A RESOLUTION

TO URGE AND REQUEST THE FORMATION OF A PANEL CONSISTING OF THE OFFICE OF ACADEMIC AFFAIRS, INFORMATION TECHNOLOGY SERVICES, FACULTY SENATE, STAFF SENATE, AND STUDENT GOVERNMENT TO DISCUSS VIABLE ALTERNATIVE OPTIONS OF STUDENT RESPONSE SYSTEMS THAT CAN BE IMPLEMENTED AT LSU

PARAGRAPH 1: WHEREAS, IN BETWEEN THE LAST SCHOOL YEAR AND THE CURRENT SCHOOL YEAR, THE COST OF STUDENT RESPONSE SYSTEMS AT LSU HAS RISEN; AND

PARAGRAPH 2: WHEREAS, THESE RISING COSTS CAN BEAR FINANCIAL BURDENS ON STUDENTS WHO ARE ALREADY SPENDING A SUBSTANTIAL AMOUNT OF MONEY ON OTHER RESOURCES NECESSARY FOR THEIR STUDIES; AND

PARAGRAPH 3: WHEREAS, THERE ARE NUMEROUS COST-EFFECTIVE OPTIONS OF STUDENT RESPONSE SYSTEMS AVAILABLE FOR TEACHERS AND STUDENTS TO USE; AND

PARAGRAPH 4: WHEREAS, OTHER SEC SCHOOLS, SUCH AS UNIVERSITY OF MISSISSIPPI AND AUBURN UNIVERSITY, HAVE ADOPTED USE OF MORE COST-EFFECTIVE STUDENT RESPONSE SYSTEMS; AND

PARAGRAPH 5: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A COMMITTEE FOCUSED ON IMPLEMENTING NEW AND COST-EFFECTIVE STUDENT RESPONSE SYSTEMS WILL BE FORMED AND INCLUDE ALL AFOREMENTIONED PARTIES; AND

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO THE APPROPRIATE HEADS OF EACH OF THE INVOLVED PARTIES (OFFICE OF ACADEMIC AFFAIRS, INFORMATION TECHNOLOGY SERVICES, FACULTY SENATE, STAFF SENATE, AND STUDENT GOVERNMENT)

PARAGRAPH 7: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
