A RESOLUTION

TO HONOR MIKE VI FOR HIS NINE (9) YEARS OF SERVICE TO THE COMMUNITY
OF THE LOUISIANA STATE UNIVERSITY

PARAGRAPH 1: WHEREAS, MIKE VI LIVED AS AN INTEGRAL PART OF OUR UNIVERSITY'S TRADITION AND CULTURE AS HE SERVED AS A LIVING SYMBOL OF SCHOOL SPIRIT; AND

PARAGRAPH 2: WHEREAS, MIKE VI PROVED TO BE A SYMBOL OF SPIRIT NOT ONLY TO LSU, BUT THROUGHOUT THE NATION AS HE EMBODIED EVERYTHING POSITIVE AND VIRTUOUS ABOUT THIS UNIVERSITY; AND

PARAGRAPH 3: WHEREAS, LSU'S STUDENT GOVERNMENT HELD A MEMORIAL IN HONOR OF MIKE VI WHERE STUDENT BODY PRESIDENT ZACK FAIRCLOTH ACCURATELY PORTRAYED THE SIGNIFICANCE OF MIKE'S EXISTENCE ON OUR CAMPUS AS HE STATED, "MIKE TAUGHT US HOW TO FIGHT LIKE TIGERS AND WE ARE FOREVER GRATEFUL FOR THE OPPORTUNITY TO MAKE HIM A PART OF OUR LIVES AS LSU STUDENTS."; AND

PARAGRAPH 4: WHEREAS, THE LSU COMMUNITY EXTENDS SPECIAL RECOGNITION AND APPRECIATION TO DR. DAVID BAKER, HIS STAFF, AND ALL VETERINARY STUDENT CARETAKERS THAT PLAYED SUCH A VITAL ROLE IN MIKE VI'S DEVELOPMENT AND WELL-BEING OVER THE PAST NINE (9) YEARS; AND

PARAGRAPH 5: WHEREAS, WITHOUT THEIR DEVOTED TIME, DEDICATION, AND SERVICE OUR UNIVERSITY WOULD NOT BE PRIVILEGED TO HOUSE MIKE VI AS A MEMBER OF THE TIGER COMMUNITY.

PARAGRAPH 6: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT WE HONOR MIKE VI AND HIS TRAINERS FOR THEIR NINE YEARS OF SERVICE TO THE LOUISIANA STATE UNIVERSITY COMMUNITY, AND

PARAGRAPH 7: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO DR. DAVID BAKER, PROFESSOR AND DIRECTOR OF THE DIVISION OF LABORATORY ANIMAL MEDICINE; AND THE LSU ATHLETIC DEPARTMENT.

PARAGRAPH 8: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
