A BILL

**TO AMEND THE STUDENT GOVERNMENT COLLEGE COUNCIL CONSTITUTION
AND BYLAWS**

PARAGRAPH 1: WHEREAS, RECENTLY, THE NAME OF THE COLLEGE COUNCIL SERVING MEMBERS OF THE GRADUATE SCHOOL UNDERWENT A NAME CHANGE; AND

PARAGRAPH 2: WHEREAS, THIS CHANGE OF NAME LEFT SOME PORTIONS OF THE COLLEGE COUNCIL CONSTITUTION AND BYLAWS TO APPEAR UNCLEAR WHEN REFERRING TO THE GRADUATE SCHOOL'S COLLEGE COUNCIL; AND

PARAGRAPH 3: WHEREAS, CURRENTLY, ARTICLE I, SECTIONS 1 AND 2 APPEAR AS FOLLOWS:

SECTION 1. THE NAME OF THESE ORGANIZATIONS WILL BE STUDENT GOVERNMENT COLLEGE COUNCILS AT LOUISIANA STATE UNIVERSITY. THE COLLEGE COUNCILS SHALL BE COMPOSED OF THE FOLLOWING ACADEMIC AREAS: COLLEGE OF AGRICULTURE, COLLEGE OF ART AND DESIGN, E.J. OURSO COLLEGE OF BUSINESS, SCHOOL OF THE COAST AND ENVIRONMENT, COLLEGE OF ENGINEERING, GRADUATE SCHOOL, COLLEGE OF HUMAN SCIENCES AND EDUCATION, COLLEGE OF HUMANITIES AND SOCIAL SCIENCES, MANSHIP SCHOOL OF MASS COMMUNICATION, COLLEGE OF MUSIC AND DRAMATIC ARTS, COLLEGE OF SCIENCE, UNIVERSITY COLLEGE CENTER FOR ADVISING AND COUNSELING, UNIVERSITY COLLEGE CENTER FOR FRESHMAN YEAR, AND SCHOOL OF VETERINARY MEDICINE.

SECTION 2. IN ORDER TO FACILITATE GRADUATE STUDENTS BECOMING ENGAGED IN STUDENT LIFE AND TO ENCOURAGE GRADUATE STUDENT PARTICIPATION IN STUDENT GOVERNMENT, THE FOLLOWING EXCEPTIONS TO THE COLLEGE COUNCIL REQUIREMENTS LISTED HEREIN SHALL BE MADE:

A. THE GRADUATE SCHOOL ASSOCIATION (GSA) SHALL FUNCTION IN PLACE OF THE GRADUATE SCHOOL COLLEGE COUNCIL.

A. THE GSA SHALL OPERATE UNDER ITS OWN CONSTITUTION, AN UPDATED COPY OF WHICH SHALL BE KEPT ON FILE WITH BOTH THE STUDENT GOVERNMENT

VICE PRESIDENT AND SPEAKER PRO TEMPORE OF THE STUDENT SENATE.

B. THE GSA SHALL ELECT ITS OFFICERS AS STIPULATED IN ITS CONSTITUTION; *AND*

PARAGRAPH 4: WHEREAS, ARTICLE I, SECTIONS 1 AND 2 SHALL INSTEAD APPEAR AS FOLLOWS, TO IMPROVE CLARITY:

SECTION 1. THE NAME OF THESE ORGANIZATIONS WILL BE STUDENT GOVERNMENT COLLEGE COUNCILS AT LOUISIANA STATE UNIVERSITY. THE COLLEGE COUNCILS SHALL BE **RECOGNIZED BY THE FOLLOWING NAMES, AND BE REPRESENTATIVE OF THEIR RESPECTIVE ACADEMIC AREAS:** COLLEGE OF AGRICULTURE **COLLEGE COUNCIL** COLLEGE OF ART AND DESIGN **COLLEGE COUNCIL**, E.J. OURSO COLLEGE OF **BUSINESS COLLEGE COUNCIL**, SCHOOL OF THE COAST AND ENVIRONMENT **COLLEGE COUNCIL**, COLLEGE OF ENGINEERING **COLLEGE COUNCIL**, GRADUATE SCHOOL **COLLEGE COUNCIL (ALSO KNOWN AS GRADUATE STUDENT ASSOCIATION OR GSA)**, COLLEGE OF HUMAN SCIENCES AND EDUCATION **COLLEGE COUNCIL**, COLLEGE OF HUMANITIES AND SOCIAL SCIENCES **COLLEGE COUNCIL**, MANSHIP SCHOOL OF MASS COMMUNICATION **COLLEGE COUNCIL**, COLLEGE OF MUSIC AND DRAMATIC ARTS **COLLEGE COUNCIL**, COLLEGE OF SCIENCE **COLLEGE COUNCIL**, UNIVERSITY COLLEGE CENTER FOR ADVISING AND COUNSELING **COLLEGE COUNCIL**, UNIVERSITY COLLEGE CENTER FOR FRESHMAN YEAR **COLLEGE COUNCIL**, AND SCHOOL OF VETERINARY MEDICINE **COLLEGE COUNCIL**.

A. THE GRADUATE STUDENT ASSOCIATION (GSA) SHALL OPERATE UNDER ITS OWN CONSTITUTION AS A **DEPARTMENT OF STUDENT GOVERNMENT. AN UPDATED COPY OF THIS CONSTITUTION SHALL BE KEPT ON FILE WITH BOTH THE STUDENT GOVERNMENT VICE PRESIDENT AND SPEAKER PRO TEMPORE OF THE STUDENT SENATE.**

B. THE GSA SHALL ELECT ITS OFFICERS AS STIPULATED IN ITS CONSTITUTION.

PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE STUDENT GOVERNMENT CONSTITUTION AND BYLAWS BE AMENDED IN THE ABOVE LISTED MANNER, AND

PARAGRAPH 6: BE IT RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO ALISA JONES, STUDENT GOVERNMENT FINANCIAL ADVISOR; AND

ARLETTE HENDERSON, STUDENT GOVERNMENT
LEGISLATIVE BRANCH ADVISOR.

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS ($2/3$) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
