A RESOLUTION

**TO URGE AND REQUEST THE OUTTAKES AND TAKE 5 TO COLLABORATE IN
CREATING AND PROVIDING A UNIFORM INVENTORY BETWEEN THE TWO
STORES**

- PARAGRAPH 1:** WHEREAS, THERE EXISTS A SELECTION OF ITEMS IN OUTTAKES THAT THE TAKE 5 DOES NOT SELL AND A SELECTION OF ITEMS IN THE TAKE 5 THAT OUTTAKES DOES NOT SELL; AND
- PARAGRAPH 2:** WHEREAS, STUDENTS WHO LIVE NEAR ONE STORE OR THE OTHER MAY HAVE TO TRAVEL ACROSS CAMPUS TO PURCHASE SPECIFIC ITEMS THAT THEY NEED IN CERTAIN SITUATIONS; AND
- PARAGRAPH 3:** WHEREAS, THE TREK FROM ONE STORE TO THE OTHER COULD ENCOURAGE STUDENTS TO SEEK OTHER VENUES OFF-CAMPUS WHICH CAN BE DANGEROUS FOR STUDENTS AND ON-CAMPUS RESIDENTS, ESPECIALLY DURING THE LATE HOURS OF THE NIGHT; AND
- PARAGRAPH 4:** WHEREAS, IT WOULD BE BENEFICIAL FOR THE TWO STORES TO COMPARE THEIR LISTS OF MEDICINAL PRODUCTS AND TOILETRIES IN ORDER TO ADEQUATELY SUPPLY AND PROVIDE A UNIFORM INVENTORY TO STUDENTS ACROSS CAMPUS.
- PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT OUTTAKES AND TAKE 5 COLLABORATE IN CREATING AND PROVIDING A UNIFORM INVENTORY BETWEEN THE TWO STORES; AND
- PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO MARGOT CARROLL, ASSISTANT VICE PRESIDENT OF LSU AUXILIARY SERVICES.
- PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE

PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL
ACTION, OR IF VETOED BY THE PRESIDENT AND
