A FINANCE BILL

TO ALLOCATE A MAXIMUM OF FOUR THOUSAND DOLLARS AND ZERO CENTS (\$4,000.00) FROM THE STUDENT GOVERNMENT LEGISLATIVE CONTINGENCY ACCOUNT TO FUND FIVE (5) MEMBERS OF SIGMA TAU DELTA TO ATTEND THE 2017 SIGMA TAU DELTA INTERNATIONAL CONVENTION IN LOUISVILLE, KENTUCKY FROM MARCH 29-APRIL 2, 2017

PARAGRAPH 1: WHEREAS, THE LSU CHAPTER OF SIGMA TAU DELTA IS A REGISTERED STUDENT ORGANIZATION AND REQUESTING TRAVEL ASSISTANCE; AND

PARAGRAPH 2: WHEREAS, SIGMA TAU DELTA BECAME A NEW STUDENT ORGANIZATION AT LSU IN THE FALL OF 2016; AND

PARAGRAPH 3: WHEREAS, SIGMA TAU DELTA ENCOURAGES CULTURAL STIMULATION ON COLLEGE CAMPUSES AND PROMOTE INTEREST IN LITERATURE AND THE ENGLISH LANGUAGE IN SURROUNDING COMMUNITIES; AND

PARAGRAPH 4: WHEREAS, TIMOTHY LEONARD, GRADUATE ADVISOR OF THE LSU CHAPTER OF SIGMA TAU DELTA, WILL BE RECEIVING A NATIONAL AWARD; AND

PARAGRAPH 5: WHEREAS, THE SIGMA TAU DELTA CHAPTER HAS BEEN ALLOCATED A TABLE AT THE CONFERENCE IN ORDER TO PUBLICIZE AND PROMOTE LOUISIANA STATE UNIVERSITY; AND

PARAGRAPH 6: WHEREAS, SIGMA TAU DELTA WILL BE HOSTING A FUNDRAISER ON FEBRUARY 11, 2017 IN THE UNION BALLROOM WITH HOPES TO RAISE ADDITIONAL FUNDING AND SET A FOUNDATIONAL BUDGET FOR THEIR ORGANIZATIONS FINANCIAL SUCCESS; AND

PARAGRAPH 7: WHEREAS, THE REQUESTED FUNDS SHALL BE ALLOCATED AS FOLLOWS:

AIRFARE AND FES: \$2495.00

A. INCLUDING \$449.00 AIRFARE PER PERSON

B. INCLUDING \$50.00 BAGGAGE FEE PER PERSON
TRANSPORTATION TO AIRPORT: \$100.00
HOTEL: \$1,112 PLUS TAX
A. INCLUDING \$139.00 PER NIGHT PER ROOM
TOTAL SUM OF COSTS: \$3,707 PLUS TAX

PARAGRAPH 8: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF FOUR THOUSAND DOLLARS AND ZERO CENTS (\$4,000.00) FROM THE STUDENT GOVERNMENT LEGISLATIVE CONTINGENCY ACCOUNT TO COVER FLIGHT AND HOTEL COSTS FOR 5 SIGMA TAU DELTA MEMBERS TO ATTEND THE SIGMA TAU DELTA 2017 INTERNATIONAL CONVENTION IN LOUISVILLE, KY FROM MARCH 29-APRIL 2, AND

PARAGRAPH 9: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO Ms ALISA JONES, STUDENT GOVERNMENT FINANCIAL COORDINATOR, AND TIMOTHY LEONARD, SIGMA TAU DELTA GRADUATE ADVISOR.

PARAGRAPH 10: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
