A FINANCE BILL

**TO ALLOCATE A MAXIMUM OF FIFTEEN THOUSAND DOLLARS AND ZERO CENTS
(\$15,000.00) FROM THE STUDENT SENATE SURPLUS ACCOUNT TO FUND
DANCE MARATHON AT LSU'S 2017 BIG EVENT'S FLOORING AND STAGING
COSTS**

- PARAGRAPH 1:** WHEREAS, DANCE MARATHON AT LSU IS CURRENTLY THE LARGEST STUDENT LED PHILANTHROPIC ORGANIZATION ON CAMPUS WITH A RECORDED NUMBER OF 764 LSU STUDENT PARTICIPANTS AT THEIR 2016 BIG EVENT; AND
- PARAGRAPH 2:** WHEREAS, OVER THE PAST THREE YEARS DANCE MARATHON AT LSU HAS RAISED A TOTAL OF \$554,069.72 TO DIRECTLY BENEFIT OUR LADY OF THE LAKE CHILDREN'S HOSPITAL IN BATON ROUGE; AND
- PARAGRAPH 3:** WHEREAS, ALL FUNDS RAISED THROUGHOUT THE YEAR GO DIRECTLY TO THEIR PHILANTHROPY WHILE ALL OPERATING COSTS ARE FUNDED THROUGH PARTNERSHIPS FORMED WITHIN THE BATON ROUGE COMMUNITY; AND
- PARAGRAPH 4:** WHEREAS, THE REQUESTED FUNDS WILL HELP TO COVER THE EXPENSES THAT ACCOMPANY THE PRODUCTION OF THEIR BIG EVENT'S FLOORING AND STAGE SETUP; AND
- PARAGRAPH 5:** WHEREAS, DANCE MARATHON WILL SUFFICIENTLY REPRESENT AND ACKNOWLEDGE STUDENT GOVERNMENT'S FINANCIAL SUPPORT THROUGH SEVERAL DIFFERENT FORMS OF OUTREACH AND ADVERTISEMENT; AND
- PARAGRAPH 6:** WHEREAS, THE APPROPRIATED FUNDS WILL BE ALLOCATED AS FOLLOWS:

BIG EVENT FLOORING AND STAGE COSTS:
STUDENT GOVERNMENT: \$15,000.00
OTHER DM PARTNERSHIP CONTRIBUTIONS:
\$12,000.00

TOTAL COSTS: \$27,000.00

PARAGRAPH 7: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE STUDENT SENATE ALLOCATE A MAXIMUM OF FIFTEEN THOUSAND DOLLARS AND ZERO CENTS (\$15,000.00) FROM THE STUDENT SENATE SURPLUS ACCOUNT TO FUND DANCE MARATHON AT LSU'S 2017 BIG EVENT, AND

PARAGRAPH 8: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO BILL MATTERA, DANCE MARATHON ADVISOR; MS. ALISA JONES STUDENT GOVERNMENT FINANCIAL COORDINATOR.

PARAGRAPH 9: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS ($2/3$) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
