A FINANCE BILL

TO ALLOCATE A MAXIMUM OF TWO HUNDRED EIGHTY-FIVE DOLLARS AND SIXTY CENTS (\$285.60) FROM THE STUDENT GOVERNMENT INITIATIVES ACCOUNT TO FUND 3,600 COFFEE SLEEVES TO RAISE AWARENESS OF SEXUAL VIOLENCE THROUGH THE WE'RE COMMITTED CAMPAIGN.

PARAGRAPH 1: WHEREAS, STUDENTS FREQUENTLY PURCHASE HOT BEVERAGES FROM CAMPUS DINING LOCATIONS AND USE THE STANDARD PROTECTIVE COFFEE SLEEVE OPTION OFFERED; AND

PARAGRAPH 2: WHEREAS, COFFEE SLEEVES DECORATED WITH A WE'RE COMMITTED GRAPHIC WILL INCREASE THE LIKELIHOOD OF IMPORTANT THOUGHT AND DISCUSSION REGARDING SEXUAL VIOLENCE ON CAMPUS AS THE SLEEVES WILL BE DISTRIBUTED AT VARIOUS CAMPUS DINING LOCATIONS; AND

PARAGRAPH 3: WHEREAS, STUDENT GOVERNMENT SUPPORT IN PREVENTING SEXUAL VIOLENCE ON CAMPUS IS ESSENTIAL TO MOVING FORWARD IN CREATING A SAFE ENVIRONMENT FOR ALL STUDENTS; AND

PARAGRAPH 4: WHEREAS, THE APPROPRIATED FUNDS WILL BE ALLOCATED AS FOLLOWS:

1. TWO CASES OF KRAFT COFFEE SLEEVES (3,600)
 - A. $\$136.80 \times 2 = \273.60
 2. SHIPPING AND HANDLING
 - B. \$12.00

TOTAL: \$285.60

PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF TWO HUNDRED EIGHTY-FIVE DOLLARS AND SIXTY CENTS (\$285.60) BE ALLOCATED FROM THE STUDENT GOVERNMENT STUDENT GOVERNMENT INITIATIVES ACCOUNT TO FUND THE WE'RE COMMITTED COFFEE SLEEVES TO RAISE AWARENESS OF SEXUAL VIOLENCE, AND

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO ALISA JONES, STUDENT GOVERNMENT FINANCIAL COORDINATOR; AND MARGOT CARROLL, EXECUTIVE DIRECTOR OF AUXILIARY SERVICES.

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL
