**A FINANCE BILL**

**TO ALLOCATE A MAXIMUM OF EIGHT HUNDRED NINETY DOLLARS AND EIGHTY FIVE CENTS (890.85) FROM THE LEGISLATIVE CONTINGENCY ACCOUNT TO FUND THE LSU C.A.R.E.S REMEMBRANCE CEREMONY**

**PARAGRAPH 1:** WHEREAS, THIS EVENT IS DESIGNED TO HONOR THE LIVES AND LEGACIES OF FELLOW TIGERS WHO HAVE PASSED AWAY WITHIN THE LAST CALENDAR YEAR; AND

**PARAGRAPH 2:** WHEREAS, THE INAUGURAL CEREMONY TO RECOGNIZE THE PASSING OF LSU STUDENTS WILL TAKE PLACE ON WEDNESDAY, APRIL 5; AND

**PARAGRAPH 3:** WHEREAS, LSU C.A.R.E.S. IS COMMITTED TO CONTINUE SUPPORTING LSU STUDENTS WHILE FOCUSING ON THE WELL-BEING OF STUDENTS AND PROMOTING A COMMUNITY THAT CARES ABOUT EACH OF ITS MEMBERS; AND

**PARAGRAPH 4:** WHEREAS, THE APPROPRIATED FUNDS WILL BE ALLOCATED AS FOLLOWS:

1. TABLES (6 TABLES AT \$5 PER TABLE): \$30
2. TABLE LINENS (\$10 PER TABLE): \$60
3. FRUIT TRAY: \$225
4. WATER/JUICE: \$48
5. COFFEE/LINENS/GRATUITY: \$124.85
6. INVITATIONS: \$403

**TOTAL: \$890.85**

**PARAGRAPH 5:** THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF EIGHT HUNDRED NINETY DOLLARS AND EIGHTY FIVE CENTS (**\$890.85**) BE ALLOCATED FROM THE LEGISLATIVE CONTINGENCY ACCOUNT TO FUND THE LSU C.A.R.E.S REMEMBRANCE CEREMONY, AND

**PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO DR. MARI FUENTES-MARTIN, LSU ASSOCIATE VICE-PRESIDENT & DEAN OF STUDENTS; ALISA J. JONES, FINANCIAL COORDINATOR; ARLETTE HENDERSON, ASSISTANT TO THE DEAN OF STUDENTS; ZACK FAIRCLOTH, LSU STUDENT GOVERNMENT PRESIDENT; AND TRACY BLANCHARD, ASSISTANT DEAN OF STUDENTS & ASSOCIATE DIRECTOR, ADVOCACY.

**PARAGRAPH 7:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL
