A FINANCE BILL

TO ALLOCATE A MAXIMUM OF TWO THOUSAND NINE HUNDRED FORTY DOLLARS AND ZERO CENTS (2940.00) FROM THE STUDENT GOVERNMENT INITIATIVES ACCOUNT TO FUND FORTY-NINE (49) FROSTED VINYL DECAL NAME LABELS ON THE DOORS OF TEN (10) UNIVERSITY BUILDINGS.

PARAGRAPH 1: WHEREAS, THE EXTERIOR OF THE LSU QUADRANGLE CURRENTLY LACKS THE CLEAR IDENTIFICATION OF BUILDING NAMES; AND

PARAGRAPH 2: WHEREAS, THE INSTALLATION OF THESE NAME STICKERS WILL PROVIDE STUDENTS WITH A QUICK AND EASILY VIABLE WAY TO LOCATE THE BUILDING THEY ARE IN SEARCH OF AND MAKE ON-CAMPUS BUILDINGS LOOK MORE UNIFORM AND PROFESSIONAL; AND

PARAGRAPH 3: WHEREAS, THESE SIGNS WILL BE COMPOSED OF A FROSTED VINYL DECAL THAT WILL BE PLACED ON THE INSIDE OF EACH GLASS DOOR FOR DURABILITY AND UPKEEP; AND

PARAGRAPH 4: WHEREAS, THE FUNDS WILL BE ALLOCATED AS FOLLOWS:
VINYL DECAL SIGNS:
49 DECAL SIGNS @ \$60.00 EACH
TOTAL COST: \$2,940.00

PARAGRAPH 5: WHEREAS, THE LOCATION, NUMBER OF SIGNS, AND COST PER BUILDING OF THESE VINYL DECAL SIGNS WILL BE AS FOLLOWS:

PARAGRAPH 6: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF TWO THOUSAND NINE HUNDRED SIXTY DOLLARS AND ZERO CENTS (\$2940.00) BE ALLOCATED FROM THE STUDENT SENATE LEGISLATIVE INITIATIVES ACCOUNT TO FUND AND INSTALL FORTY-NINE (49) DECALS ON THE DOORS OF TEN BUILDINGS LOCATED ON OR NEAR THE EXTERIOR QUAD, AND

PARAGRAPH 7: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO ALISA JONES, THE LSU STUDENT GOVERNMENT FINANCIAL COORDINATOR AND TAMMY MILLICAN, THE EXECUTIVE DIRECTOR FOR LSU FACILITY AND PROPERTY OVERSIGHT.

PARAGRAPH 8: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS ($2/3$) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
