**A FINANCE BILL**

**TO ALLOCATE SEVENTY DOLLARS AND FORTY-SEVEN CENTS (\$70.47) OUT OF THE STUDENT GOVERNMENT INITIATIVES ACCOUNT TO FUND THREE (3) TRIPODS FOR THE LIBRARY FOR STUDENTS TO RENT**

**PARAGRAPH 1:** WHEREAS, ALLOWING STUDENTS TO RENT TRIPODS FROM MIDDLETON LIBRARY WILL ENCOURAGE STUDENTS TO USE ON CAMPUS RESOURCES PROVIDED FOR THEM BY THE UNIVERSITY; AND

**PARAGRAPH 2:** WHEREAS EACH TRIPOD COSTS \$23.49 AND COMES WITH A TRAVEL BAG; AND

**PARAGRAPH 3:** WHEREAS, MIDDLETON LIBRARY HAS A HIGH DEMAND FOR TRIPOD RENTALS FOR VIDEO PROJECTS IN CLASS; AND

**PARAGRAPH 4:** WHEREAS, TRIPOD RENTALS HAVE BEEN WIDELY SUCCESSFUL IN THE PAST; AND

**PARAGRAPH 5:** WHEREAS, THE FUNDS WILL BE ALLOCATED AS FOLLOWS:

3 TRIPODS @ \$23.49 EACH  
TOTAL: \$70.47

**PARAGRAPH 6:** THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF SEVENTY DOLLARS AND FORTY-SEVEN CENTS (\$70.47) FROM THE STUDENT GOVERNMENT INITIATIVES ACCOUNT TO FUND THREE TRIPODS FOR RENT FROM MIDDLETON LIBRARY; AND

**PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO Ms. PLANK, HEAD OF CIRCULATION AT LSU LIBRARIES.

**PARAGRAPH 8:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
