17 **PARAGRAPH 2:** WHEREAS, WE'RE COMMITTED WORKS TO END SEXUAL
18 VIOLENCE, CREATES AND MAINTAINS COMMUNITY OF RESPECT,
19 AND PROVIDES TRAINING AND EDUCATION ON THE ISSUE OF
20 SEXUAL VIOLENCE ; AND

28 **PARAGRAPH 5:** WHEREAS, THE FUNDS SHALL BE ALLOCATED AS FOLLOWS:



44 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY
45 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
