A RESOLUTION

TO URGE AND REQUEST LSU AUXILIARY SERVICES TO CONSIDER MAKING ALL VENDING SERVICES PAW POINT ACCESSIBLE.

PARAGRAPH 1: WHEREAS, SOME VENDING MACHINES ARE ALREADY UTILIZING PAW POINTS; AND PAW POINTS ACCOUNT FOR THE PRIMARY USE OF MEAL PLANS FOR STUDENTS.


PARAGRAPH 2: WHEREAS, LSU SOME VENDING SERVICES ONLY UTILIZE DEBIT CARD, TIGER CASH, OR CASH ONLY; AND MAKING ALL VENDING SERVICES PAW POINT ACCESSIBLE WOULD ACCESSING ALL VENDING MACHINES SIMPLER.


PARAGRAPH 3: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE TO URGE AND REQUEST LSU AUXILIARY SERVICES TO CONSIDER MAKING ALL VENDING SERVICES PAW POINT ACCESSIBLE.

PARAGRAPH 4: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO BEN SOUTHARD, VICE PRESIDENT OF OPERATIONS, MARGOT CARROLL, ASSISTANT VICE PRESIDENT, KURT CAILLOUET, DIRECTOR OF FACILITIES & OPERATIONS, BRANDI ROBERTS, DIRECTOR OF FINANCE.

PARAGRAPH 5: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
