7 A BILL

8 TO AMEND THE COLLEGE COUNCIL CONSTITUTION

9 PARAGRAPH 1: WHEREAS, THE GRADUATE SCHOOL COLLEGE COUNCIL HAS HAD  
10 LITTLE TO NO GRADUATE STUDENT PARTICIPATION; AND

11 PARAGRAPH 2: WHEREAS, THE GRADUATE STUDENT ASSOCIATION (GSA), AS A  
12 STUDENT ORGANIZATION, HAS RECENTLY EMERGED AS THE  
13 OFFICIAL LIAISON ORGANIZATION FOR GRADUATE STUDENTS TO  
14 UNIVERSITY ADMINISTRATION; AND

15 PARAGRAPH 3: WHEREAS, THE GSA WILL ACT IN PLACE OF THE GRADUATE  
16 SCHOOL COLLEGE COUNCIL AND BECOME A PART OF STUDENT  
17 GOVERNMENT; AND

18 PARAGRAPH 4: WHEREAS, THE GRADUATE STUDENT ASSOCIATION WILL  
19 OPERATE UNDER ITS OWN CONSTITUTION AND ELECTION  
20 PROCESS; AND

21 PARAGRAPH 5: WHEREAS, THE GSA CONSTITUTION WILL BE ATTACHED TO AND  
22 CONSIDERED AN AUXILIARY DOCUMENT TO THIS BILL; AND

23 PARAGRAPH 6: WHEREAS, THE COLLEGE COUNCIL CONSTITUTION SHALL BE  
24 AMENDED TO READ AS FOLLOWS:

25 Article I – Name

26 SECTION 1. The name of these organizations will be Student Government College Councils  
27 at Louisiana State University. The College Councils shall be composed of the following Academic  
28 Units and/or Divisions Areas: College of Agriculture, College of Art and Design, E. J. Ourso College  
29 of Business, School of the Coast and Environment, College of Engineering, Graduate School,  
30 College of Human Sciences and Education, College of Humanities and Social Sciences, Paul M.  
31 Hebert Law Center, Manship School of Mass Communication, College of Music and Dramatic Arts,  
32 College of Science, University College Center for Advising and Counseling, University College  
33 Center for Freshman Year, and School of Veterinary Medicine.

34 SECTION 2. In order to facilitate graduate students becoming engaged in student life and  
35 to encourage graduate student participation in Student Government, the following exceptions to  
36 the College Council requirements listed herein shall be made:


- 37 A. The Graduate School Association (GSA) shall function in place of the Graduate  
38 School College Council.
  - 39 a. The GSA shall operate under its own Constitution, an updated copy  
40 of which shall be kept on file with both the Student Government Vice  
41 President and Speaker pro tempore of the Student Senate.
  - 42 b. The GSA shall elect its officers as stipulated in its Constitution.

55 **PARAGRAPH 7:** THEREFORE, BE IT ENACTED BY THE LOUISIANA  
56 STATE UNIVERSITY STUDENT SENATE THAT THE  
57 COLLEGE COUNCIL CONSTITUTION BE AMENDED AS DESCRIBED  
58 TO HAVE THE GRADUATE STUDENT ASSOCIATION FUNCTION AS  
59 THE GRADUATE STUDENT COLLEGE COUNCIL, AND  
60

61 **PARAGRAPH 8:** BE IT RESOLVED THAT A COPY OF THIS RESOLUTION  
62 BE TRANSMITTED TO DR. MICHELLE MASSÉ, DEAN OF THE  
63 GRADUATE SCHOOL AND GSA ADVISOR.

65 **PARAGRAPH 9:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO - THIRDS  
66 (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY  
67 THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL  
68 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY  
69 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
