10 **TO URGE AND REQUEST THAT THE WATER FOUNTAIN IN THE LSU VISITOR CENTER**  
11 **BE CLEANED AND REPAIRED.**

13 **PARAGRAPH 1:** WHEREAS, THERE IS RUST, SEDIMENT, AND CALCIUM BUILD-UP  
14 SURROUNDING THE FAUCET; AND

16 **PARAGRAPH 2:** WHEREAS, 3,000 ENROLLED STUDENTS VISITED THE VISITOR  
17 CENTER LAST SEMESTER; AND



19 **PARAGRAPH 3:** WHEREAS, THE LSU VISITOR CENTER IS A MAJOR TRAFFIC AREA  
20 FOR A MAJORITY OF INCOMING LSU STUDENTS AND ALUMNI AND  
21 CAN REFLECT NEGATIVELY ON THE UNIVERSITY.

23 **PARAGRAPH 4:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA  
24 STATE UNIVERSITY STUDENT SENATE THAT THE WATER  
25 FOUNTAIN IN THE LSU VISITOR CENTER BE CLEANED AND  
26 REPAIRED, AND

28 **PARAGRAPH 5:** BE IT FURTHER RESOLVED THAT A COPY OF THIS  
29 RESOLUTION BE TRANSMITTED TO TAMMY MILLICAN,  
30 ASSISTANT DIRECTOR OF FACILITY SERVICES.

32 **PARAGRAPH 6:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A  
33 SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU  
34 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON  
35 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE  
36 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON  
37 THE DATE OF SUCH APPROVAL.
