15 THE SEMESTER ARE LISTED ON THE CHANCELLOR'S HONOR ROLL;

19 AVERAGES OF 3.5 TO 3.9 IN AT LEAST 15 CREDIT HOURS ARE LISTED

22 **PARAGRAPH 3:** WHEREAS, 10 OF 13 OTHER SOUTHEASTERN CONFERENCE
23 UNIVERSITIES REQUIRE 12 CREDIT HOURS FOR THE CHANCELLOR'S
24 HONOR ROLL AND THE DEAN'S LIST; AND


