AN EXECUTIVE ORDER

TO ALLOCATE A MAXIMUM OF TWELVE THOUSAND THREE HUNDRED FOUR DOLLARS AND ONE CENT (\$12,304.01) FROM THE STUDENT GOVERNMENT SURPLUS ACCOUNT TO FUND BASIC OFFICE FURNITURE IN THE STUDENT GOVERNMENT EXECUTIVE OFFICE

PARAGRAPH 1: WHEREAS, THE STUDENT GOVERNMENT EXECUTIVE OFFICE CURRENTLY LACKS NECESSARY FURNITURE TO HOLD MEETINGS; AND

PARAGRAPH 2: WHEREAS, A FURNISHED ROOM IS NECESSARY TO ENABLE EXECUTIVE STAFF MEMBERS TO COLLABORATE AND WORK EFFECTIVELY; AND

PARAGRAPH 3: WHEREAS, THE STUDENT GOVERNMENT EXECUTIVE OFFICE OFTEN SERVES AS THE FIRST IMPRESSION OF STUDENT GOVERNMENT FOR STUDENTS, FACULTY, AND STAFF WHO ENTER THE OFFICE, AND SHOULD BE TREATED AS SUCH; AND

PARAGRAPH 4: WHEREAS, THE FUNDS WILL BE ALLOCATED AS FOLLOWS:

2 ROUND CHAIRS AT \$975 EACH - \$1,950.00
3 NO-ARM CHAIRS AT \$ 950 EACH - \$2,850.00
2 KIT-GANGING AT \$15 EACH- \$30.00
1 COFFEE TABLE AT \$289.50 EACH - \$289.50
2 TABLE-ENDS AT \$228 EACH - \$456.00
2 BIG TABLES AT \$1,549.00 EACH - \$3,098.00
12 STOOLS AT \$289.64 EACH- \$3,475.68
2 VERTICAL WIRE-MANAGERS AT \$18 EACH - \$36.00
1 POWER BOX AT \$118.83 EACH - \$118.83

TOTAL - \$12,304.01

PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT TWELVE THOUSAND THREE HUNDRED FOUR DOLLARS AND ONE CENT (\$12,304.01) BE ALLOCATED FROM SURPLUS TO FUND OFFICE FURNITURE FOR THE STUDENT GOVERNMENT EXECUTIVE OFFICE, AND

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO CORTNEY GREAVIS, STUDENT GOVERNMENT FINANCIAL COORDINATOR.

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A ONE HALF VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
