**A FINANCE BILL**

**TO ALLOCATE ONE THOUSAND THREE HUNDRED DOLLARS AND ZERO CENTS (\$1,300.00) FROM THE STUDENT GOVERNMENT INITIATIVES ACCOUNT TOWARD STUDENT BUSINESS CARDS AND STUDENT BUSINESS CARD HOLDERS PROVIDED BY THE OLINDE CAREER CENTER.**

**PARAGRAPH 1:** WHEREAS, BUSINESS CARDS PROVIDE STUDENTS WITH A PROFESSIONAL MEANS OF COMMUNICATION WITH THE POTENTIAL TO BOLSTER JOB PROSPECTS; AND

**PARAGRAPH 2:** WHEREAS, THESE BUSINESS CARDS WILL BE PROVIDED BY THE OLINDE CAREER CENTER; AND

**PARAGRAPH 3:** WHEREAS, THE OLINDE CAREER CENTER HAS COMMITTED TO SUPPLEMENT ANY ADDITIONAL COST ASSOCIATED WITH PRODUCTION OF THE BUSINESS CARDS; AND

**PARAGRAPH 4:** WHEREAS, THE REQUESTED FUNDS WILL BE ALLOCATED AS FOLLOWS:

1. BUSINESS CARDS (20 PER STUDENT, PER SEMESTER)
    - a. \$600
  2. PLASTIC BUSINESS CARD HOLDERS:
    - a. \$700
- Total: \$1,300.00.**

**PARAGRAPH 5:** THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MINIMUM OF ONE THOUSAND THREE HUNDRED DOLLARS AND ZERO CENTS (\$1,300.00) FROM THE STUDENT GOVERNMENT INITIATIVES ACCOUNT TO FUND THE STUDENT BUSINESS CARDS AND STUDENT BUSINESS CARD HOLDERS FOR THE REMAINDER OF THE 2017-2018 ACADEMIC YEAR

**PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO JESSE DOWNS, THE DIRECTOR OF THE OLINDE CAREER CENTER, AND CORTNEY GREAVIS, STUDENT GOVERNMENT FINANCIAL COORDINATOR.

**PARAGRAPH 7:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
