A RESOLUTION

TO URGE AND REQUEST THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LA DOTD) TO REPAIR THE BRIDGE ON SOUTH CAMPUS DR. LEADING TO WEST LAKESHORE DR.

PARAGRAPH 1: WHEREAS, THE BRIDGE IS CONSTANTLY BEING USED BY THE BATON ROUGE COMMUNITY AND BY STUDENTS DRIVING STANDARD VEHICLES; AND

PARAGRAPH 2: WHEREAS, LOUISIANA STATE UNIVERSITY TIGER TRAILS BUS SYSTEM FREQUENTLY CROSSES THIS BRIDGE IN 30-MINUTE INTERVALS; AND

PARAGRAPH 3: WHEREAS, THE BRIDGE'S RAILING HAS BEEN SEVERELY DAMAGED, CAUSING IT TO BE DANGEROUS FOR CONTINUED USE; AND

PARAGRAPH 4: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE LOUISIANA DOTD RESOLVE THIS ISSUE BY REPAIRING THE RAILING TO ENSURE ITS SAFETY, AND

PARAGRAPH 5: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO TAMMY MILLICAN, LSU EXECUTIVE DIRECTOR OF FACILITY AND PROPERTY OVERSIGHT, AND NICHOLAS FAGERBURG, BRIDGE MAINTENANCE ENGINEER FOR THE LOUISIANA DOTD.

PARAGRAPH 6: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
