**A RESOLUTION**

**TO SUPPORT THE OFFICE OF DISABILITY SERVICES FOR ALLOWING REGISTERED STUDENTS WHO ARE CAPABLE OF BEING NOTE TAKERS TO SERVE IN THAT CAPACITY**

- PARAGRAPH 1:** WHEREAS, PREVIOUSLY, ANY STUDENT REGISTERED WITH THE OFFICE OF DISABILITY SERVICES WAS BARRED FROM BEING A NOTE TAKER FOR OTHER STUDENTS; AND
- PARAGRAPH 2:** WHEREAS, SOME OF THESE DISABILITIES DO NOT HINDER THAT STUDENT'S ABILITY TO TAKE NOTES FOR OTHER STUDENTS WITH DISABILITIES; AND
- PARAGRAPH 3:** WHEREAS, THE OFFICE OF DISABILITY SERVICES REVIEWS EACH NOTE TAKER REQUEST FOR STUDENTS REGISTERED WITH THE OFFICE ON A CASE BY CASE BASIS.
- PARAGRAPH 4:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THIS BODY SUPPORTS THE OFFICE OF DISABILITY SERVICES' EFFORTS TO ALLOW ALL STUDENTS WHO ARE REGISTERED WITH THE OFFICE OF DISABILITY SERVICES WHO ARE CAPABLE OF BEING NOTE TAKERS TO SERVE IN THAT CAPACITY.
- PARAGRAPH 5:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO STUDENT BODY PRESIDENT JASON BADEAUX, ASSOCIATE DEAN OF STUDENTS AND DIRECTOR OF DISABILITY SERVICES BENJAMIN CORNWELL, AND STUDENT GOVERNMENT FACULTY ADVISOR MICHELLE LOWERY
- PARAGRAPH 6:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
