A RESOLUTION

**TO URGE AND REQUEST THE OFFICE OF STUDENT ADVOCACY AND
ACCOUNTABILITY TO ADD A CATEGORY TO THE LSU CARES ONLINE REPORTING
SYSTEM FOR FACULTY POLICY VIOLATIONS**

- PARAGRAPH 1:** WHEREAS, LSU CARES IS A SERVICE PROVIDED BY THE OFFICE OF STUDENT ADVOCACY AND ACCOUNTABILITY THAT EXISTS AS A WAY FOR STUDENTS AND FACULTY TO REPORT CERTAIN GRIEVANCES; AND
- PARAGRAPH 2:** WHEREAS, EXISTING CATEGORIES INCLUDE ACADEMIC MISCONDUCT (FOR FACULTY), BIAS OR DISCRIMINATION, HAZING, AND STUDENT GRIEVANCES; AND
- PARAGRAPH 3:** WHEREAS, THERE IS NO CATEGORY DEDICATED TO FACULTY POLICY VIOLATIONS; AND
- PARAGRAPH 4:** WHEREAS, SUCH A CATEGORY WOULD INCLUDE REPORTS FOR CONCENTRATED STUDY PERIOD VIOLATIONS, EXCUSED ABSENCE VIOLATIONS, PLUS/MINUS VIOLATIONS, FAILING TO POST MID-TERM GRADES, AND OTHERS; AND
- PARAGRAPH 5:** WHEREAS, SUCH A CATEGORY WOULD BE A WAY FOR STUDENTS TO REPORT FACULTY POLICY VIOLATIONS PRIOR TO OR IN ADDITION TO A GRADE APPEAL; AND
- PARAGRAPH 6:** WHEREAS, COMPLAINTS IN THIS FIELD WOULD BE SUBMITTED TO THE OFFICE OF ACADEMIC AFFAIRS AND/OR SPECIFIC COLLEGES AND DEPARTMENTS; AND
- PARAGRAPH 7:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE LSU CARES SERVICE FEATURE A CATEGORY FOR FACULTY POLICY VIOLATIONS, AND
- PARAGRAPH 8:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO TRACY BLANCHARD, ASSISTANT DEAN OF STUDENTS & ASSOCIATE DIRECTOR OF ADVOCACY; THE OFFICE OF ACADEMIC AFFAIRS; AND JASON BADEAUX, STUDENT BODY PRESIDENT
- PARAGRAPH 9:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
