15 **PARAGRAPH 1:** WHEREAS, STUDENT GOVERNMENT IS CURRENTLY WORKING

20 **PARAGRAPH 2:** WHEREAS, THE UNION POSSESSES A PERMANENT ART
21 COLLECTION OF WHICH MORE THAN HALF IS IN STORAGE AND
22 CONCEALED FROM PUBLIC VIEWING; AND

24 **PARAGRAPH 3:** WHEREAS, THIS COLLECTION OF ART CONTAINS WORKS BY
25 NOTABLE REGIONAL ARTISTS AND AIMS TO TELL STORIES OF
26 HISTORICAL LOUISIANA AND LSU'S HISTORY; AND

28 **PARAGRAPH 4:** WHEREAS, THIS COLLECTION IS A PRICELESS AND VALUABLE LSU
29 TREASURE THAT SHOULD BE PROMOTED AND DISPLAYED TO
30 STUDENTS AND THE PUBLIC TO INSPIRE LEARNING AND
31 KNOWLEDGE AND INFORM SAID INDIVIDUALS OF ONE OF LSU'S
32 VALUABLE POSSESSIONS.
