7 **A BILL**

8 **TO AMEND THE SENATE RULES OF ORDER**

9 **PARAGRAPH 1:** WHEREAS, THE STUDENT SENATE DOES NOT CURRENTLY HAVE
10 AN APPOINTED SERGEANT AT ARMS, AND;

11 **PARAGRAPH 2:** WHEREAS, THE STUDENT SENATE HAS NOT BEEN ABLE TO KEEP A
12 SERGEANT AT ARMS ON STAFF FOR ANY EXTENDED AMOUNT OF
13 TIME, AND;

14 **PARAGRAPH 3:** WHEREAS, IF THIS POSITION WERE ABLE TO BE HELD BY A
15 MEMBER OF THE STUDENT SENATE THAT PERSON WOULD BE
16 MORE INVESTED IN MAINTAINING HIS OR HER POSITION , AND;

17 **PARAGRAPH 4:** WHEREAS, THE SENATE RULES OF ORDER SHOULD BE AMENDED
18 TO READ:

19 D. All officers and staff herein listed may not be members of the Senate except for the Sergeant At Arms.

20 **Rule 2.12 Sergeant at Arms Duties**

21 A. To assist the presiding officer in maintaining order in the Senate chamber, and upon the request of the
22 presiding officer, to escort any disorderly Senator or member of the gallery out of the chamber.

23 B. To coordinate and supervise the activities of the Legislative Aides in preparing the chamber for a
24 meeting of the Senate and return it back to its proper order upon adjournment.

25 C. To receive from the Chief of Staff of the Executive branch a list of all officers to report during Executive
26 Officer Reports and provide this list to the presiding officer before the Senate is called to order.

27 D. To obtain a list of all members of the public that wish to address the Senate and provide this list to the
28 presiding officer before the Senate is called to order.

29 E. To ensure that all members of the Student Senate UPHOLD to the Code of Ethics found in Article 1 of
30 the LSU Student Government Bylaws.

31 **PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA
32 STATE UNIVERSITY STUDENT SENATE THAT THE
33 AFOREMENTIONED AMENDMENTS TO THE SENATE
34 RULES OF ORDER BE ADOPTED.

35 **PARAGRAPH 6:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A
36 TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT
37 SENATE AND SIGNATURE BY THE PRESIDENT, UPON
38 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF
39 VETOED BY THE PRESIDENT AND SUBSEQUENTLY
40 1028 APPROVED BY THE SENATE, ON THE DATE OF
41 SUCH APPROVAL.
