15 **PARAGRAPH 1:** WHEREAS, THE SEC EXCHANGE IS A GATHERING OF
16 REPRESENTATIVES FROM ALL FOURTEEN SEC SCHOOLS' STUDENT
17 GOVERNMENTS TO EXCHANGE IDEAS ON HOW TO IMPROVE THEIR
18 RESPECTIVE UNIVERSITIES, AND;

20 **PARAGRAPH 2:** WHEREAS, THE 2014 SEC EXCHANGE WAS HELD AT AUBURN
21 UNIVERSITY, AND

23 **PARAGRAPH 3:** WHEREAS, LSU WAS PRIVILEGED TO HAVE BEEN ABLE TO SEND
24 10 REPRESENTATIVES FROM STUDENT GOVERNMENT TO SHARE
25 INITIATIVES AND PROGRAMS WE HAVE AT OUR UNIVERSITY
26 WHILE ALSO BEING INSPIRED BY INITIATIVES AND PROGRAMS AT

29 **PARAGRAPH 4:** WHEREAS, REGISTRATION WAS ONE HUNDRED DOLLARS AND
30 ZERO CENTS (\$100.00) PER PERSON WITH A TOTAL OF TEN PEOPLE

32 **PARAGRAPH 5:** THEREFORE, BE IT ENACTED BY THE LOUISIANA
33 STATE UNIVERSITY AND AGRICULTURAL AND
34 MECHANICAL COLLEGE STUDENT SENATE THAT A
35 MAXIMUM OF ONE THOUSAND DOLLARS AND ZERO CENTS
36 (\$1,000.00) FROM THE STUDENT GOVERNMENT SURPLUS
37 ACCOUNT WILL BE ALLOCATED TO FUND THE REGISTRATION OF
38 THE 2014 SEC EXCHANGE REPRESENTATIVES, AND

40 **PARAGRAPH 6:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS
41 (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY
42 THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL
43 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY
44 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
