12 **LEGISLATIVE GENERAL CONTINGENCY ACCOUNT TO FINANCE FIFTEEN (15)**
13 **GRADUATE STUDENTS TO ATTEND THE AMERICAN SPEECH-LANGUAGE-HEARING**
14 **ASSOCIATION CONFERENCE IN ORLANDO, FLORIDA FROM NOVEMBER 20TH-22ND AS**
15 **REPRESENTATIVES OF LOUISIANA STATE UNIVERSITY (LSU)**

17 **PARAGRAPH 1:** WHEREAS, 15 GRADUATE STUDENT MEMBERS OF THE LSU
18 NATIONAL STUDENT SPEECH LANGUAGE HEARING ASSOCIATION
19 (NSSLHA) AND THE DEPARTMENT OF COMMUNICATION
20 SCIENCES AND DISORDERS HAVE BEEN SELECTED TO ATTEND A
21 SPEECH LANGUAGE HEARING ASSOCIATION (ASHA) CONFERENCE
22 IN ORLANDO, FLORIDA; AND

24 **PARAGRAPH 2:** WHEREAS, THIS IS A PRESTIGIOUS HONOR AND STUDENTS WILL
25 HAVE THE OPPORTUNITY TO DISCUSS RESEARCH TOPICS AND
26 NETWORK WITH REPRESENTATIVES FROM ALL OVER THE
27 COUNTRY; AND

29 **PARAGRAPH 3:** WHEREAS, THE STUDENTS HAVE FUNDRAISED ONE THOUSAND
30 AND FIFTY THREE DOLLARS AND FOURTEEN CENTS (\$1053.14) TO
31 HELP WITH THE TOTAL COST FOR THE TRIP; AND

33 **PARAGRAPH 4:** WHEREAS, THE FUNDS WOULD COVER REGISTRATION FEES; AND

38 **PARAGRAPH 6:** THEREFORE, BE IT ENACTED BY THE LOUISIANA
39 STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM
40 OF FOUR THOUSAND ONE HUNDRED AND TWENTY FIVE DOLLARS
41 AND ZERO CENTS (\$4125.00) FROM THE STUDENT GOVERNMENT
42 LEGISLATIVE GENERAL CONTINGENCY BE ALLOCATED TO FUND
43 THESE 15 GRADUATE STUDENTS TO ATTEND THE ASHA
44 CONFERENCE IN ORLANDO, FLORIDA AND;

46 **PARAGRAPH 7:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS
47 (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY
48 THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL
49 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY
50 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
