12 **TO CONGRATULATE DR. STANLEY WILDER ON HIS SELECTION AS THE DEAN OF**  
13 **LIBRARIES AND TO WARMLY WELCOME HIM BACK TO LOUISIANA STATE UNIVERSITY**

15 **PARAGRAPH 1:** WHEREAS, LOUISIANA STATE UNIVERSITY (LSU) NAMED DR.  
16 STANLEY WILDER THE DEAN OF LSU LIBRARIES EFFECTIVE JULY  
17 1<sup>ST</sup>, 2014; AND

19 **PARAGRAPH 2:** WHEREAS, DR. WILDER EARNED HIS UNDERGRADUATE DEGREE  
20 AT THE UNIVERSITY OF WISCONSIN, HIS MASTER'S DEGREE FROM  
21 COLUMBIA UNIVERSITY, AND HIS MBA AT THE UNIVERSITY OF  
22 ILLINOIS AT CHICAGO; AND

24 **PARAGRAPH 3:** WHEREAS, DR. WILDER HAS SERVED AS A VISITING PROGRAM  
25 OFFICER FOR THE ASSOCIATION OF RESEARCH LIBRARIES AND AS  
26 BOTH ASSISTANT AND ASSOCIATE DEAN AT THE UNIVERSITY OF  
27 ROCHESTER FOR A DECADE; AND

29 **PARAGRAPH 4:** WHEREAS, DR. WILDER HAS PUBLISHED HIS RESEARCH ON ATL  
30 AND IN THE CHRONICLE OF HIGHER EDUCATION IN 2005; AND

32 **PARAGRAPH 5:** WHEREAS, DR. WILDER HAS SERVED LSU LIBRARIES PREVIOUSLY  
33 AS THE ASSISTANT TO THE DEAN FOR ADMINISTRATIVE SERVICES  
34 AND ASSISTANT DEAN FOR TECHNICAL AND FINANCIAL  
35 SERVICES.

37 **PARAGRAPH 6:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA  
38 STATE UNIVERSITY STUDENT SENATE THAT DR.  
39 STANLEY WILDER BE CONGRATULATED ON HIS SELECTION AS  
40 DEAN OF THE LSU LIBRARIES AND OFFICIALLY WELCOMED TO  
41 LSU, AND

43 **PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS  
44 RESOLUTION BE TRANSMITTED TO DR. STANLEY  
45 WILDER, DEAN OF THE LSU LIBRARIES; SIGRID KELSEY,  
46 DIRECTOR OF LIBRARY COMMUNICATIONS AND PUBLICATIONS;  
47 AND DR. STUART BELL, EXECUTIVE VICE CHANCELLOR AND  
48 PROVOST.

50 **PARAGRAPH 8:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A  
51 SIMPLE MAJORITY (ONE HALF PLUS ONE) VOTE OF THE LSU  
52 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON  
53 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE  
54 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON  
55 THE DATE OF SUCH APPROVAL.
