**A RESOLUTION**

**TO CONGRATULATE DR. TODD QUEEN ON HIS SELECTION AS THE DEAN OF THE COLLEGE OF MUSIC & DRAMATIC ARTS AND TO WARMLY WELCOME HIM TO LOUISIANA STATE UNIVERSITY**

**PARAGRAPH 1:** WHEREAS, LOUISIANA STATE UNIVERSITY (LSU) NAMED DR. TODD QUEEN THE DEAN OF THE COLLEGE OF MUSIC & DRAMATIC ARTS EFFECTIVE JULY 1, 2014; AND

**PARAGRAPH 2:** WHEREAS, DR. QUEEN IS AN ACCOMPLISHED ADMINISTRATOR, PERFORMER, AND EDUCATOR, HOLDING AN UNDERGRADUATE DEGREE FROM BRIGHAM YOUNG UNIVERSITY AND GRADUATE DEGREES FROM THE EASTMAN SCHOOL OF MUSIC ; AND

**PARAGRAPH 3:** WHEREAS, DR. QUEEN FORMERLY SERVED AS THE CHAIR OF THE DEPARTMENT OF MUSIC, THEATRE, AND DANCE AT COLORADO STATE UNIVERSITY (CSU); AND

**PARAGRAPH 4:** WHEREAS, DR. QUEEN WAS INSTRUMENTAL IN ADVANCING THE PROFILE OF THE DEPARTMENT BY SECURING \$2 MILLION IN GIFTS AND PLEDGES, INCLUDING 10 NEW ENDOWED SCHOLARSHIPS FOR STUDENTS WHILE AT CSU; AND

**PARAGRAPH 5:** WHEREAS, LOUISIANA IS A GLORIOUS LOCATION FOR A MUSICIAN TO PERFORM AND STUDY, AND DR. QUEEN IS EXCITED TO JOIN THE LSU COMMUNITY.

**PARAGRAPH 6:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE THAT DR. TODD QUEEN BE CONGRATULATED ON HIS SELECTION AS DEAN OF THE COLLEGE OF MUSIC & DRAMATIC ARTS AND OFFICIALLY WELCOMED TO LSU, AND

**PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO DR. TODD QUEEN, DEAN, COLLEGE OF MUSIC & DRAMATIC ARTS; RONETTE BOSHEA, PUBLICITY AND MARKETING COORDINATOR, SCHOOL OF MUSIC; AND DR. STUART BELL, EXECUTIVE VICE CHANCELLOR AND PROVOST.

**PARAGRAPH 8:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
