7 **A RESOLUTION**

8 **TO URGE AND REQUEST THE OFFICE OF THE BURSAR TO NOTIFY STUDENTS OF ADDITIONAL**  
9 **CHARGES TO FEE BILLS AFTER THEY HAVE BEEN PAID**

11 **PARAGRAPH 1:** WHEREAS, FEE BILLS ARE AN IMPORTANT AND PRESSING ASPECT OF  
12 REGISTERING EVERY SEMESTER; AND

13  
14 **PARAGRAPH 2:** WHEREAS, A STUDENT'S SCHEDULE MAY BE PURGED SHOULD A NON-  
15 ZERO FEE BILL BALANCE REMAIN; AND

16  
17 **PARAGRAPH 3:** WHEREAS THE OFFICE OF THE BURSAR CURRENTLY ONLY EMAILS A  
18 NOTIFICATION WHEN FEE BILLS ARE POSTED AND FOUR (4) DAYS BEFORE  
19 THE BEGINNING OF THE SEMESTER; AND

21 **PARAGRAPH 4:** WHEREAS, A STUDENT CAN GO MULTIPLE WEEKS BELIEVING HIS/HER  
22 FEE BILL HAS BEEN PAID WHEN IT HAS HAD ADDITIONAL CHARGES  
23 ADDED; AND

25 **PARAGRAPH 5:** WHEREAS, SUCH NOTIFICATION COULD BE AN EMAIL INFORMING THE  
26 STUDENT THAT HE/SHE NO LONGER HAS A ZERO BALANCE ON HIS/HER  
27 FEE BILL, DETAILS OF THE CHARGES, AND DUE DATE SHOULD BE NOTED.

29 **PARAGRAPH 6:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE  
30 UNIVERSITY STUDENT SENATE THAT THE OFFICE OF THE  
31 BURSAR NOTIFY STUDENTS OF ADDITIONAL CHARGES TO FEE BILLS  
32 AFTER THEY HAVE BEEN PAID AND

33  
34 **PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS  
35 RESOLUTION BE TRANSMITTED TO LAURENCE S. BUTCHER,  
36 DIRECTOR OF THE OFFICE OF THE BURSAR.

38 **PARAGRAPH 8:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE  
39 MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE  
40 AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR  
41 PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND  
42 SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH  
43 APPROVAL.
