**A RESOLUTION**

**TO URGE AND REQUEST THAT THE TIGERCASH KIOSK IN MIDDLETON LIBRARY  
BE MOVED TO A LOCATION THAT IS ACCESSIBLE IN THE NEW 24-HOUR STUDY  
SPACE**

**PARAGRAPH 1:** WHEREAS, THE TIGERCASH KIOSK IN MIDDLETON LIBRARY IS CURRENTLY LOCATED IN A SECTION OF THE LIBRARY THAT IS NOT OPEN FOR 24 HOURS; AND

**PARAGRAPH 2:** WHEREAS, THE PRINTING AND COPYING SERVICES PROVIDED BY MIDDLETON LIBRARY ARE AN ESSENTIAL RESOURCE FOR MANY STUDENTS; AND

**PARAGRAPH 3:** WHEREAS, TIGERCASH IS THE ONLY FORM OF PAYMENT ACCEPTED TO USE THESE SERVICES; AND

**PARAGRAPH 4:** WHEREAS, LACK OF CONVENIENT ACCESS TO THE TIGERCASH KIOSK DURING THE LIBRARY'S NEW EXTENDED HOURS OF OPERATION IS POTENTIALLY PREVENTING STUDENTS FROM COMPLETING WORK TIMELY AND SUCCESSFULLY.

**PARAGRAPH 5:** THEREFORE, BE IT RESOLVED THAT THE LOUISIANA STATE UNIVERSITY STUDENT SENATE URGE AND REQUEST MIDDLETON LIBRARY TO MOVE THE TIGERCASH KIOSK TO AN ACCESSIBLE LOCATION IN THE 24-HOUR STUDY SPACE, AND

**PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO STANLEY WILDER, DEAN OF LSU LIBRARIES.

**PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.


