7 **A RESOLUTION**

8 **TO ESTABLISH A COMMITTEE TO REEVALUATE AND OVERSEE THE ALLOCATION OF THE GRADUATE ORGANIZATIONAL RELIEF FUND (ORF)**

9 **PARAGRAPH 1:** WHEREAS, THE FIRST DUTY OF THIS COMMITTEE WILL BE TO RE-EVALUATE THE GRADUATE ORF AND HOW IT IS AWARDED TO STUDENTS; AND

10 **PARAGRAPH 2:** WHEREAS, THE PURPOSE OF THIS COMMITTEE WILL BE TO REEVALUATE AND OVERSEE THE ALLOCATION OF THE GRADUATE ORF; AND

11 **PARAGRAPH 3:** WHEREAS, THIS COMMITTEE WILL BE COMPOSED OF THE GRADUATE SCHOOL COLLEGE COUNCIL (GCC) PRESIDENT OR HIS OR HER DESIGNEE, THE GRADUATE STUDENT ASSOCIATION (GSA) PRESIDENT OR HIS OR HER DESIGNEE, ONE REPRESENTATIVE THAT IS A GRADUATE SCHOOL STUDENT SENATOR, AND AT LEAST THREE (3) GRADUATE STUDENTS UNAFFILIATED WITH GCC, GSA OR STUDENT GOVERNMENT, TO BE APPOINTED BY THE STUDENT BODY PRESIDENT.

12 **PARAGRAPH 4:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A COMMITTEE BE ESTABLISHED TO REEVALUATE AND OVERSEE THE ALLOCATION OF THE GRADUATE ORF, AND

13 **PARAGRAPH 5:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO OLIVIA OLINDE, GRADUATE SCHOOL COLLEGE COUNCIL PRESIDENT; MELVIN JACKSON, GRADUATE STUDENT ASSOCIATION PRESIDENT; DR. GARY BYERLY, DEAN OF THE GRADUATE SCHOOL; AND CAROL ADAMS, ADMINISTRATIVE PROGRAM SPECIALIST FOR THE GRADUATE SCHOOL..

14 **PARAGRAPH 6:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
