8 **TO URGE AND REQUEST LSU AUXILIARY SERVICES TO REDESIGN THE LSU TIGER**
9 **CARD TO INCLUDE A VALID SIGNATURE OF THE LSU STUDENT**

10 **PARAGRAPH 1:** WHEREAS, IN ORDER TO VOTE, VOTING ID LAWS IN LOUISIANA
11 REQUIRE VALID PHOTO IDENTIFICATION THAT CONTAINS THE
12 NAME AND SIGNATURE OF THE APPLICANT; AND

13 **PARAGRAPH 2:** WHEREAS, CURRENTLY LSU TIGER CARDS DO NOT CONTAIN
14 PRINTED SIGNATURES, AND AS A RESULT THEY CAN NOT BE USED
15 AT POLLING LOCATIONS; AND

16 **PARAGRAPH 3:** WHEREAS, MANY STUDENTS DO NOT HAVE LOUISIANA STATE
17 ISSUED IDS BUT DO HAVE LSU TIGER CARDS; AND

18 **PARAGRAPH 4:** WHEREAS, BY PLACING SIGNATURES ON THE LSU TIGER CARDS,
19 MANY STUDENTS WILL BE ABLE TO PARTICIPATE IN LOUISIANA
20 ELECTIONS BASED ON GUIDELINES SET BY THE LOUISIANA
21 DEPARTMENT OF STATE; AND

22 **PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA
23 STATE UNIVERSITY STUDENT SENATE THAT LSU
24 AUXILIARY SERVICES REDESIGN THE LSU TIGER CARD TO
25 INCLUDE A VALID SIGNATURE OF THE STUDENT, AND

26 **PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS
27 RESOLUTION BE TRANSMITTED TO MARGOT CAROL,
28 EXECUTIVE DIRECTOR OF AUXILIARY SERVICES AND STEPHEN
29 BARR, DIRECTOR OF RETAIL DEVELOPMENT & TECHNOLOGY.

30 **PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A
31 SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU
32 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON
33 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE
34 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON
35 THE DATE OF SUCH APPROVAL.
