9 **TO URGE AND REQUEST THE LSU DEPARTMENT OF ATHLETICS AND THE LSU**
10 **SUSTAINABILITY DEPARTMENT TO PLACE RECYCLING BINS THROUGHOUT TIGER**

15 **PARAGRAPH 1:** WHEREAS, THE AMOUNT OF RECYCLABLES THAT ARE THROWN
16 AWAY MAY HAVE A NEGATIVE EFFECT ON THE LOUISIANA
17 ECOSYSTEM; AND

19 **PARAGRAPH 2:** WHEREAS, STUDENTS, FACULTY MEMBERS, COACHES, AND FANS
20 SHOULD HAVE THE OPTION TO PROPERLY RECYCLE ALL OF THE
21 ITEMS THAT ARE PURCHASED AT THE CONCESSION STANDS; AND

23 **PARAGRAPH 3:** WHEREAS, THE SUSTAINABILITY DEPARTMENT AND THE
24 DEPARTMENT OF ATHLETICS SHOULD REEVALUATE THE
25 CONSERVATION EFFORTS OF TIGER STADIUM, THE PETE
26 MARAVICH ASSEMBLY CENTER, AND ALEX BOX STADIUM TO
27 HELP REDUCE THE AMOUNT OF RECYCLABLES THAT ARE
28 IMPROPERLY DISPOSED.

49 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE
50 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON
51 THE DATE OF SUCH APPROVAL.
