10 **TO ALLOCATE A MAXIMUM OF ONE THOUSAND DOLLARS AND ZERO CENTS**  
11 **(\$1,000.00) FROM THE LEGISLATIVE GENERAL CONTINGENCY ACCOUNT TO FUND**  
12 **FIVE LSU DANCE MINOR’S LODGING TO PERFORM AN ORIGINAL DANCE BY THE LSU**  
13 **DANCE DEPARTMENT HEAD, AT THE NEW YORK CITY DANCE ARTS FESTIVAL**  
14 **(NYCDAF).**

16 **PARAGRAPH 1:** WHEREAS, SANDRA PARKS CREATED AN ORIGINAL  
17 CHOREOGRAPHED PIECE AND SUBMITTED TO THE NYCDAF; AND

19 **PARAGRAPH 2:** WHEREAS, THE NYCDAF COMMITTEE ACCEPTED THE PIECE;

22 **PARAGRAPH 3:** WHEREAS, MRS. PARKS ASKED FIVE LSU DANCE MINORS: MACY  
23 DUNNE, MOLLY RUSSELL, MARLIN GRIGSBY, AMY HERRISS, AND  
24 HARLEE TRAUTMAN, TO PERFORM THE PIECE AT NYCDAF; AND

26 **PARAGRAPH 4:** WHEREAS, THE COST FOR ONE HOTEL ROOM WOULD ROUGHLY BE  
27 ONE THOUSAND DOLLARS AND ZERO CENTS (\$1,000.00); AND

29 **PARAGRAPH 5:** WHEREAS, THE COST FOR PLANE TICKETS WOULD ROUGHLY BE  
30 THREE HUNDRED AND SEVENTY-TWO DOLLARS AND ZERO CENTS  
31 (\$372.00); AND

33 **PARAGRAPH 6:** WHEREAS, THE COST FOR 12 MEALS WOULD ROUGHLY BE ONE  
34 HUNDRED AND TWENTY DOLLARS AND ZERO CENTS (\$120); AND

36 **PARAGRAPH 7:** WHEREAS, THE COST FOR TAXIS FOR FOUR DAYS WOULD  
37 ROUGHLY BE ONE THOUSAND FOUR HUNDRED AND FORTY  
38 DOLLARS AND ZERO CENTS(\$1,440); AND

40 **PARAGRAPH 8:** WHEREAS, THE TOTAL COST FOR ALL FIVE OF THE DANCERS  
41 WOULD BE FOUR THOUSAND NINE HUNDRED DOLLARS AND ZERO  
42 CENTS (\$4,900); AND

44 **PARAGRAPH 9:** WHEREAS, ATTENDING THE NYCDAF WOULD HELP THE  
45 CAREERS OF FIVE LOUISIANA STATE UNIVERSITY STUDENTS; AND

47 **PARAGRAPH 10:** WHEREAS, THIS OPPORTUNITY WOULD STRENGTHEN THE  
48 REPUTATION OF LSU AND PROMOTE EXTRA-CURRICULAR  
49 ACTIVITIES OF THE STUDENTS.

51 **PARAGRAPH 11:** THEREFORE, BE IT ENACTED BY THE LOUISIANA  
52 STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM
