9 **PARAGRAPH 1:** WHEREAS, GARTH BROOKS IS PLANNING A WORLD TOUR IN THE COMING MONTHS AND;

10 **PARAGRAPH 2:** WHEREAS, GARTH BROOKS' SONG "CALLIN' BATON ROUGE" IS A TRADITION BEFORE EVERY HOME FOOTBALL GAME MOST OTHER HOME OR ON CAMPUS SPORTING EVENTS AND;
