13 **PARAGRAPH 1:** WHEREAS, THE CURRENT LSU DINING LOCATIONS MAP DOES
14 NOT PROVIDE INFORMATION ON LOCATIONS THAT OFFER
15 VEGETARIAN, VEGAN, GLUTEN FREE, OR KOSHER OPTIONS; AND

17 **PARAGRAPH 2:** WHEREAS, MANY STUDENTS SEEK OUT THESE DINING OPTIONS
18 AND WOULD BENEFIT FROM A CLEAR MAP DEFINING THESE
19 LOCATIONS; AND

21 **PARAGRAPH 3:** WHEREAS, THE MAP IS A GREAT RESOURCE FOR ALL STUDENTS
22 AND VISITORS TO THE LSU CAMPUS AND SHOULD BE AS CLEAR
23 AND RESOURCEFUL AS POSSIBLE.

25 **PARAGRAPH 4:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA
26 STATE UNIVERSITY STUDENT SENATE THAT LSU
27 DINING DENOTE VEGETARIAN, VEGAN, GLUTEN FREE, AND
28 KOSHER DINING OPTIONS ON THE LSU DINING MAP, AND

30 **PARAGRAPH 5:** BE IT FURTHER RESOLVED THAT A COPY OF THIS
31 RESOLUTION BE TRANSMITTED TO DELORIS BROWN,
32 DIRECTOR OF OPERATIONS, LSU DINING.

34 **PARAGRAPH 6:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A
35 SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU
36 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON
37 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE
38 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON
39 THE DATE OF SUCH APPROVAL.
