10 **TO URGE AND REQUEST LSU DINING TO PROVIDE FRESHER AND HEALTHIER DINING**  
11 **OPTIONS IN THE ATRIUM CAFE**

13 **PARAGRAPH 1:** WHEREAS, THE ATRIUM CAFÉ CURRENTLY DOESN'T OFFER MANY  
14 HEALTHY FOOD OPTIONS; AND

16 **PARAGRAPH 2:** WHEREAS, THE ATRIUM CAFÉ CATERS TO A LARGE PERCENTAGE  
17 OF STUDENTS IN THE COLLEGE OF ART & DESIGN; AND

19 **PARAGRAPH 3:** WHEREAS, HEALTHIER FOOD OPTIONS WOULD ALLOW THESE  
20 STUDENTS TO EAT WITHIN THEIR COLLEGE, AS WELL AS PROVIDE  
21 A HEALTHIER FOOD OPTION IN THIS AREA OF CAMPUS; AND

23 **PARAGRAPH 4:** WHEREAS, THESE OPTIONS WOULD BE INCLUDED BUT NOT  
24 LIMITED TO VEGETARIAN, VEGAN, GLUTEN FREE, AND KOSHER  
25 OPTIONS.

27 **PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA  
28 STATE UNIVERSITY STUDENT SENATE LSU DINING  
29 PROVIDE FRESHER AND HEALTHIER DINING OPTIONS IN THE  
30 ATRIUM CAFÉ.

32 **PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS  
33 RESOLUTION BE TRANSMITTED TO DELORIS BROWN,  
34 DIRECTOR OF OPERATIONS, LSU DINING.

36 **PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A  
37 SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU  
38 STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON  
39 LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE  
40 PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON  
41 THE DATE OF SUCH APPROVAL.
