A BILL

TO AMEND THE STUDENT GOVERNMENT BYLAWS

PARAGRAPH 1: WHEREAS, THE STUDENT SENATE RECENTLY PASSED LEGISLATION TO AMEND THE PROCESS OF OBTAINING A NEW SECRETARY AND UNDERSECRETARY; AND

PARAGRAPH 2: WHEREAS, THE POSITIONS NO LONGER REQUIRE AN ELECTION; AND

PARAGRAPH 3: WHEREAS, THE ORDER OF EVENTS LISTED IN ARTICLE III, SECTION 8:C SHOULD READ AS FOLLOWS:

1. Installation of newly elected Senators
 2. Installation of the newly elected President and Vice President
 3. Election of the Speaker
 4. Election of the Speaker Pro Tempore
 - ~~5. Election and installation of the Secretary~~
 - ~~6. Election and installation of the Undersecretary~~
 7. Approval of the Executive Charter
 8. Approval of the Student Government Budget
 9. Approval of the Presidential Appointments
 10. Approval of Speaker's Appointments
 11. Appointment of Members and Leadership of Standing Committees
 12. Resolutions creating temporary study or action groups and their membership
 13. Approval of any other Executive or Legislative Orders
 14. Any other legislation submitted that is deemed important and urgent by the Speaker of the Senate, or by subsequent appeal of the decision of the chair by a (1/2) majority vote of the members of the Senate

PARAGRAPH 4: THEREFORE BE IT ENACTED THAT THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE HEREBY AMEND THE STUDENT GOVERNMENT BYLAWS.

PARAGRAPH 5: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
