A FINANCE BILL

TO APPROPRIATE A MAXIMUM OF \$1,240.00 OF THE STUDENT SENATE CONTINGENCY FUND TO HELP WITH COSTS ASSOCIATED WITH AUBREY DEVILLEZ, MYLES LAROUX, AND THEODORE BURNELL WILLIAMS III ATTENDING THE AMERICAN ISRAEL PUBLIC AFFAIRS COMMITTEE POLICY CONFERENCE MARCH 3RD-6TH, 2012 IN WASHINGTON, D.C.

- PARAGRAPH 1:** WHEREAS, THE AIPAC POLICY CONFERENCE IS WHERE PRO-ISRAEL ACTIVISTS INFLUENCE POLICY, STRENGTHEN THE BOND BETWEEN UNITED STATES AND ISRAEL, AND ENSURE THAT ISRAEL REMAIN STRONG, VIBRANT, AND FREE, AND
- PARAGRAPH 2:** WHEREAS, DELEGATES AT AIPAC POLICY CONFERENCE 2012 WILL HEAR FROM AMERICAN AND ISRAELI POLITICAL LEADERS ABOUT THE IMPORTANCE OF THE U.S.-ISRAEL RELATIONSHIP, AND,
- PARAGRAPH 3:** WHEREAS, AUBREY DEVILLEZ, MYLES LAROUX, AND THEODORE BURNELL WILLIAMS III WILL BE JOINED BY STUDENT LEADERS FROM UNIVERSITIES ACROSS THE NATION, AND
- PARAGRAPH 4:** WHEREAS, FUNDING COULD NOT BE GRANTED BY PSIF AND ORF DUE TO THE STUDENT LEADERS NOT PRESENTING AT THE CONFERENCE, ONLY ATTENDING AS A DELEGATE, AND
- PARAGRAPH 5:** WHEREAS, THIS AMOUNT WOULD COVER FLIGHT EXPENSE, MEALS, AND INCIDENTALS, SUCH AS CAB FARE TO AND FROM THE AIRPORT.
- PARAGRAPH 6:** WHEREAS, THERE IS A NEED TO FUND SUCH INITIATIVES AS IT WILL REPRESENT THE UNIVERSITY IN A POSITIVE MANNER ON THE STATE LEVEL, AND GIVE THESE STUDENT LEADERS AN OPPORTUNITY TO VOLUNTEER THEIR TIME AND SERVICES, AS WELL AS, TO PARTICIPATE IN A SERIES OF PRESENTATIONS.
- PARAGRAPH 7:** THEREFORE, BE IT ENACTED BY THE STUDENT SENATE OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT A MAXIMUM OF ONE THOUSAND TWO HUNDRED AND FORTY (\$1,240.00) DOLLARS IS ALLOCATED FROM THE STUDENT SENATE CONTINGENCY FOR EXPENSES AIPAC POLICY CONFERENCE 2012.
- PARAGRAPH 8:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
