A RESOLUTION

TO SHOW THE LSU STUDENT BODY'S SUPPORT FOR HOUSE BILL 735, A BILL THAT "DEDICATES A PORTION OF STATE REVENUES FROM RIVERBOAT GAMING ACTIVITIES IN EAST BATON ROUGE PARISH TO CERTAIN ENTITIES," AUTHORED BY REPRESENTATIVES FOIL AND HONORE

- PARAGRAPH 1:** WHEREAS, HOUSE BILL 735 DEDICATES A PORTION OF STATE REVENUES GENERATED BY RIVERBOAT GAMING ACTIVITIES, BEGINNING OPERATION ON OR AFTER JULY 1, 2012, TO THE EAST BATON ROUGE PARISH HIGHER EDUCATION IMPROVEMENT FUND AND;
- PARAGRAPH 2:** WHEREAS, THIS FUND WOULD BENEFIT THE LSU FOUNDATION, THE SOUTHERN UNIVERSITY SYSTEM FOUNDATION AND THE PENNINGTON BIOMEDICAL RESEARCH FOUNDATION AND;
- PARAGRAPH 3:** WHEREAS, 40 PERCENT OF THIS FUND WOULD BE ALLOCATED TO THE LSU FOUNDATION AND;
- PARAGRAPH 4:** WHEREAS, IN THIS TIME OF FINANCIAL CRISIS, LOUISIANA STATE UNIVERSITY WOULD GREATLY BENEFIT FROM THESE FUNDS AND;
- PARAGRAPH 5:** WHEREAS, THE LSU STUDENT BODY THANKS REPRESENTATIVES FOIL AND HONORE FOR THEIR AID TO LSU AND ENCOURAGES THE LOUISIANA STATE LEGISLATURE TO FURTHER PROTECT FUNDING FOR LOUISIANA HIGHER EDUCATION.
- PARAGRAPH 6:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE SUPPORTS HOUSE BILL 735, A BILL THAT "DEDICATES A PORTION OF STATE REVENUES FROM RIVERBOAT GAMING ACTIVITIES IN EAST BATON ROUGE PARISH TO CERTAIN ENTITIES," AUTHORED BY REPRESENTATIVE FOIL AND HONORE.
- PARAGRAPH 7:** BE IT FURTHER RESOLVED, THAT A SUITABLE COPY OF THIS RESOLUTION BE SENT TO THE MEMBERS OF THE LOUISIANA STATE LEGISLATURE.
- PARAGRAPH 8:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
