A BILL

TO AMEND THE SENATE RULES OF ORDER

PARAGRAPH 1: WHEREAS, THE STUDENT SENATE HAS RECENTLY APPROVED AN EXPENDITURE TO FUND THE ACQUISITION OF CLICKERS FOR THE PURPOSE OF VOTING; AND,

PARAGRAPH 2: WHEREAS, THE RULES OF ORDER CURRENTLY REQUIRE A ROLL CALL FOR THE MOTION TO ADJOURN, AND

PARAGRAPH 3: WHEREAS, THE RULES OF ORDER SHOULD BE AMENDED TO READ:

Rule 8.4 Motion to Adjourn

- A. A motion to adjourn shall always be in order, except when the main question has been ordered.
B. The motion to adjourn shall be decided without debate.
C. In putting the question on the motion to adjourn, the presiding officer shall inform the Senate of remaining business by indicating the position in the Order of Business.
D. The motion to adjourn shall always be voted on only by electronic device a roll call vote.;

PARAGRAPH 4: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE THAT THE AFOREMENTIONED AMENDMENTS TO THE RULES OF ORDER BECOME EFFECTIVE.

PARAGRAPH 5: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
