## A BILL

## TO AMEND THE 2011-2012 STUDENT GOVERNMENT BUDGET

**PARAGRAPH 1:** WHEREAS, IN ORDER TO CORRECT THE MISCALCULATION CAUSING A DEFICIT, IT IS NECESSARY TO AMEND THE 2011-2012 STUDENT GOVERNMENT BUDGET TO CORRECT THIS MISTAKE; AND

**PARAGRAPH 2:** WHEREAS, PARAGRAPH 3 SECTION 1 OF THE STUDENT GOVERNMENT BUDGET SHOULD READ:

**Section 1: LEGISLATIVE CONTINGENCY**

These funds are appropriated to the control of the Speaker and the Student Senate, respectively, subject to notification of the Director of Finance and Chair of the Committee on Finance. These funds shall be expended as follows:

1. Speaker's Contingency	\$1,500.00
2. General Contingency	<u>\$29,335.95</u>

**PARAGRAPH 3:** THEREFORE, BE IT ENACTED BY THE STUDENT SENATE OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT THE STUDENT GOVERNMENT BYLAWS BE THUS AMENDED. , AND

**PARAGRAPH 4:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
