A BILL**TO AMEND THE STUDENT GOVERNMENT BYLAWS**

- PARAGRAPH 1:** WHEREAS, MEMBERS OF LSU STUDENT GOVERNMENT CURRENTLY CANNOT EARN GRADUATION CORDS FOR THEIR SERVICE TO THE UNIVERSITY AND;
- PARAGRAPH 2:** WHEREAS, STUDENT GOVERNMENT (IF YOU ARE DOING IT RIGHT) TAKES LOTS OF TIME AND DEDICATION, AND
- PARAGRAPH 3:** WHEREAS, STUDENTS WHO EXHIBIT SUCH DEDICATION TO OUR UNIVERSITY AND FELLOW STUDENTS SHOULD BE REWARDED WITH A MARK OF HONOR AT THE TIME OF THEIR GRADUATION;
- PARAGRAPH 4:** WHEREAS, TO REFLECT THIS CHANGE THE STUDENT GOVERNMENT BYLAWS SHOULD READ:

ARTICLE XV**Honors and Awards****Section 1. Student Government Cords**

- A. Members of Student Government may earn the honor of wearing Student Government Graduation Cords.**
- 1. Cords may be earned after serving as a member of the Executive Staff, Active College Counsels, Student Senate, or Judicial Court for a total of four (4) semesters among said bodies.**
 - 2. Cords may also be earned for holding Leadership Positions for a full term in said bodies, such as: Branch Heads, the Chief of Staff, Executive Directors and Senate Committee Chairs.**
- B. Cord honors will be formally announced at the Student Government Awards Banquet.**

PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE THAT THE STUDENT GOVERNMENT BYLAWS BE ACCORDINGLY AMENDED, AND

PARAGRAPH 6: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
