**A FINANCE BILL**

**TO ALLOCATE FOURTEEN THOUSAND EIGHTY-FOUR DOLLARS AND THIRTY-FIVE CENTS (\$14,084.35) FROM THE STUDENT GOVERNMENT INITIATIVES ACCOUNT TO FUND THE PURCHASE OF TURNING TECHNOLOGIES CLICKERS FOR THE LSU MIDDLETON LIBRARY**

- PARAGRAPH 1:** WHEREAS, NEARLY ALL INCOMING STUDENTS ARE REQUIRED TO PURCHASE A CLICKER FOR THEIR CLASSES; AND
- PARAGRAPH 2:** WHEREAS, THIS CLICKER IS THE RF TURNING TECHNOLOGIES RESPONSECARD ; AND
- PARAGRAPH 3:** WHEREAS, THE LSU ADMINISTRATION HAS DESIGNATED THE RF REPOSECARD AS THE OFFICIAL CLICKER FOR THE UNIVERSITY; AND
- PARAGRAPH 4:** WHEREAS, THE LSU MIDDLETON LIBRARY STARTED A CLICKER BORROWING PROGRAM TO ASSIST STUDENTS IN '07; AND
- PARAGRAPH 5:** WHEREAS, OVER THE YEARS THE LIBRARY HAS LOST CLICKERS DUE TO ATTRITION, WEAR AND TEAR, ECT.; AND
- PARAGRAPH 6:** WHEREAS, THE LIBRARY MUST ALSO REPLACE BATTERIES IN THE CIRCULATING CLICKERS PERIODICALLY; AND
- PARAGRAPH 7:** WHEREAS, THE LIBRARY WOULD BE BETTER ABLE TO SERVICE THE CLICKERS WITH A BATTERY TESTER, AND HAS REQUESTED SUCH; AND
- PARAGRAPH 8:** WHEREAS, THE PURCHASE OF THE AFORMENTIONED MATERIALS BY STUDENT GOVERNMENT WOULD DIRECTLY IMPACT STUDENTS FINANCIALLY AND HELP TO RE-BOLSTER MIDDLETON'S CLICKER BORROWING PROGRAM; AND
- PARAGRAPH 9:** WHEREAS, THIS EXPENDITURE WOULD COVER THE FOLLOWING ACQUISITIONS:
1. 500 RESPONSECARD RF'S - \$14,000;
  2. 50 SONY 3V CR2032 LITHIUM BATTERIES - \$25.90;
  3. ZTS MINI-MBT9R BATTERY TESTER -\$ 29.00;
  4. SHIPPING & HANDLING - \$29.45;
- PARAGRAPH 10:** THEREFORE, BE IT ENACTED BY THE STUDENT SENATE OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT FOURTEEN THOUSAND EIGHTY-FOUR DOLLARS AND THIRTY-FIVE CENTS (\$14,084.35) BE ALLOCATED FROM THE STUDENT

GOVERNMENT INITIATIVES ACCOUNT TO FUND THE PURCHASE  
OF CLICKERS FOR THE LSU MIDDLETON LIBRARY

**PARAGRAPH 11:** BE IT FURTHER RESOLVED THAT THE STUDENT SENATE  
URGES AND REQUESTS THAT ANY POTENTIAL REPLACEMENT FEES  
COLLECTED GO TOWARD PURCHASING NEW CLICKERS.

**PARAGRAPH 12:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS  
( $2/3$ ) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY  
THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL  
ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY  
APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
