A FINANCE BILL

TO APPROPRIATE THE AMOUNT OF \$380.00 (THREE HUNDRED AND EIGHTY DOLLARS) OF THE STUDENT SENATE CONTINGENCY FUND TO HELP WITH COSTS ASSOCIATED WITH PHILOSOPHY COLLOQUIUM, IN ORDER TO HAVE MARK LANCE SPEAK TO STUDENTS ON CAMPUS IN MID-NOVEMBER

PARAGRAPH 1: WHEREAS, MARK LANCE, AN ACCLAIMED PROFESSOR OF PHILOSOPHY FROM GEORGETOWN WILL BE ON CAMPUS ALREADY, WHICH PROVIDES AN EXCELLENT OPPORTUNITY FOR THE PHILOSOPHY DEPARTMENT TO HOST A LECTURE FOR ALL STUDENTS, AND

PARAGRAPH 2: WHEREAS, THE PHILOSOPHY DEPARTMENT AND STUDENTS WILL GREATLY BENEFIT FROM THE OPPORTUNITY TO LEARN FROM AND CONVERSE WITH MARK LANCE, AND

PARAGRAPH 3: WHEREAS, ALL STUDENTS ARE INVITED TO ATTEND AND ENJOY REFRESHMENTS, EVEN IF THEY ARE NOT IN THE PHILOSOPHY DEPARTMENT, PHILOSOPHY CLUB, OR COLLEGE OF HUMANITIES AND SOCIAL SCIENCES AND

PARAGRAPH 4: WHEREAS, THE PHILOSOPHY COLLOQUIUM WAS UNABLE TO RECEIVE FUNDS FROM PSIF BECAUSE THE CONFERENCE SUPPORT ACCOUNT HAS BEEN ZEROED OUT FOR THIS FISCAL YEAR, AND THE APPLICATION WAS SUBMITTED AFTER THE DEADLINE OUTLINED IN THE BYLAWS, AND

PARAGRAPH 5: WHEREAS, \$300 WILL BE GOING TO HONORARIUM MARK LANCE, AND \$80 WILL GO TOWARDS REFRESHMENTS FROM CC'S COMMUNITY COFFEE HOUSE, AN APPROVED CATERER, AND

PARAGRAPH 6: WHEREAS, MARK LANCE WILL BRING AN OPPORTUNITY FOR STUDENTS TO INTERACT WITH A COMMENDED DOCTOR OF PHILOSOPHY AND ADD TO THE INTEGRITY OF THE COLLEGE OF HUMANITIES AND SOCIAL SCIENCES THROUGH ITS ABILITY TO OFFER TO ITS STUDENTS EXCEPTIONAL OPPORTUNITIES TO ENGAGE WITH RENOWNED SPEAKERS

PARAGRAPH 7: THEREFORE, BE IT ENACTED BY THE STUDENT SENATE OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT AN AMOUNT OF THREE-HUNDRED AND EIGHTY (\$380.00) DOLLARS IS ALLOCATED FROM THE STUDENT SENATE CONTINGENCY FOR EXPENSES FOR THE PHILOSOPHY COLLOQUIUM TO HOST ACCLAIMED GEORGETOWN PROFESSOR MARK LANCE .

PARAGRAPH 8: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY

THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
