A RESOLUTION

TO URGE AND REQUEST THE DIVISION OF FINANCE AND ADMINISTRATIVE SERVICES TO PROVIDE A HYPERLINK TO DESCRIPTIONS OF EACH FEE PLACED ON THE FEE BILL.

PARAGRAPH 1: WHEREAS, CURRENTLY STUDENTS ARE UNAWARE OF WHERE TO FIND A DETAILED DESCRIPTION OF THEIR FEE BILLS ON THE PAWS WEBSITE; AND

PARAGRAPH 2: WHEREAS, THIS RESOLUTION WILL INCREASE THE TRANSPARENCY OF STUDENTS' TUITION AND FEES; AND;

PARAGRAPH 3: WHEREAS THERE SHOULD BE LINKS FEATURED ON THE FEE BILL THAT DESCRIBES NOT ONLY THE PURPOSE OF EACH FEE, BUT ALSO THE END RESULT OF THE FEE'S APPROPRIATION;

PARAGRAPH 4: WHEREAS, EACH FEE SHOULD EXHIBIT A HYPERLINK TO THE FEE'S DESCRIPTION TO EASE NAVIGATION OF THE DESCRIPTIONS;

PARAGRAPH 5: THEREFORE, BE IT RESOLVED THAT THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE URGE AND REQUEST THE DIVISION OF FINANCE AND ADMINISTRATIVE SERVICES TO PROVIDE LINKS TO A DESCRIPTION OF EACH FEE ON THE FEE BILL.

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A SUITABLE COPY OF THIS RESOLUTION BE FORWARDED TO ERIC MONDAY, VICE CHANCELLOR OF FINANCE AND ADMINISTRATIVE SERVICES AND BRIAN NICHOLLS, INTERIM CHIEF INFORMATION OFFICER.

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
