A RESOLUTION**TO URGE AND REQUEST THAT THE OFFICE OF THE REGISTRAR IMPLEMENT A DROP CONFIRMATION SYSTEM FOR ONLINE SCHEDULING**

- PARAGRAPH 1:** WHEREAS, LOUISIANA STATE UNIVERSITY ALLOWS STUDENTS TO ADD AND DROP CLASSES FOR THEIR SCHEDULES ELECTRONICALLY VIA PAWS, AND;
- PARAGRAPH 2:** WHEREAS, BEFORE THE 8TH CLASS DAY STUDENTS MAY ALSO DROP A CLASS WITHOUT RECEIVING A W, AND
- PARAGRAPH 3:** WHEREAS, STUDENTS UTILIZE THE DROP FUNCTION MOST OFTEN DURING THIS PERIOD OF TIME; AND,
- PARAGRAPH 4:** WHEREAS, CURRENTLY THERE IS NO CONFIRMATION TO DROP A CLASS AFTER YOU PRESS THE DROP BUTTON; AND
- PARAGRAPH 5:** WHEREAS, DROPPING A CLASS OFTEN HAS FAR REACHING CONSEQUENCES, INCLUDING BEING WAITLISTED OR UNABLE TO TAKE A CLASS FOR THAT SEMESTER; AND,
- PARAGRAPH 6:** WHEREAS, NEW STUDENTS MAY BE UNFAMILIAR WITH THE SCHEDULING SYSTEM; AND
- PARAGRAPH 7:** WHEREAS, THE ADDITION OF A CONFIRMATION SCREEN WOULD HELP TO PREVENT STUDENTS FROM ACCIDENTALLY DROPPING THEIR CLASSES; AND
- PARAGRAPH 8:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE URGES AND REQUESTS THAT THE REGISTRAR'S OFFICE IMPLEMENT A DROP CONFIRMATION DIALOG FOR THE SCHEDULING OF CLASSES THROUGH PAWS, AND
- PARAGRAPH 9:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL IS GIVEN TO UNIVERSITY REGISTRAR ROBERT DOOLOS.
- PARAGRAPH 10:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
