A RESOLUTION

TO URGE AND REQUEST THE EXPANSION OF TIGERCASH IN THE SURROUNDING COMMUNITY

PARAGRAPH 1: WHEREAS, TIGERCASH IS A CONVENIENT MONETARY TRANSACTION SYSTEM THAT ALLOWS PARENTS TO EASILY DEPOSIT MONEY FOR THE USE OF STUDENTS ON CAMPUS; AND

PARAGRAPH 2: WHEREAS, SEVERAL BUSINESSES IN THE SURROUNDING AREA HAVE BEGUN TO ACCEPT TIGERCASH IN ORDER TO FURTHER THE CONVENIENCE OF PAYMENT ON THE PART OF STUDENTS; AND

PARAGRAPH 3: WHEREAS, THE ACCEPTANCE OF TIGERCASH IS MUTUALLY BENEFICIAL AS A STUDENT MAY BE MORE LIKELY TO BUY AT A PARTICULAR STORE IF THEY ACCEPT TIGERCASH; AND

PARAGRAPH 4: WHEREAS, THERE ARE BUSINESSES IN THE IMMEDIATE VICINITY AND SURROUNDING LSU THAT CURRENTLY DO NOT ACCEPT TIGERCASH; AND

PARAGRAPH 5: THEREFORE, BE IT RESOLVED THAT THE LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE STUDENT SENATE URGES AND REQUESTS BUSINESSES IN THE SURROUNDING COMMUNITY TO ACCEPT TIGERCASH AS A FORM OF PAYMENT TO AIDE STUDENT CONVENIENCE, AND

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE DELIVERED TO BUSINESSES IN THE SURROUNDING AREA.

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
