A RESOLUTION

TO URGE AND REQUEST THAT THE LSU MIDDLETON LIBRARY GIVE AN ELECTRONIC REMINDER FIVE DAYS BEFORE AN ARTICLE'S DUE DATE

PARAGRAPH 1: WHEREAS, CURRENTLY THE LIBRARY AUTOMATICALLY SENDS AN E-MAIL THE DAY AN ARTICLE IS OVERDUE; AND

PARAGRAPH 2: WHEREAS, MANY STUDENTS FORGET THE DAY THAT ARTICLES ARE DUE; AND

PARAGRAPH 3: WHEREAS, SENDING OUT A NOTIFICATION FIVE DAYS BEFORE ANY PARTICULAR ARTICLE IS DUE WOULD ALLOW STUDENTS TO RETURN THE ARTICLE OR RENEW IT ELECTRONICALLY; AND

PARAGRAPH 4: WHEREAS, THIS NOTIFICATION WOULD SERVE TO HELP STUDENTS AVOID LIBRARY FINES FOR ARTICLES THEY ARE NO LONGER USING; AND

PARAGRAPH 5: WHEREAS, THIS NOTIFICATION WOULD ALSO GIVE GREATER ACCESSIBILITY TO STUDENTS THAT ARE AWAITING ARTICLES TO BE CHECKED IN ; AND

PARAGRAPH 6: THEREFORE, BE IT RESOLVED THAT THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE URGES AND REQUESTS THAT MIDDLETON LIBRARY IMPLEMENT A NOTIFICATION PROGRAM THAT E-MAILS STUDENTS FIVE DAYS BEFORE ANY PARTICULAR ARTICLE IS DUE.

PARAGRAPH 7: BE IT FURTHER RESOLVED THAT A SUITABLE COPY OF THIS RESOLUTION BE FORWARDED TO JENNIFER CARGILL, DEAN OF LIBRARIES.

PARAGRAPH 8: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT; UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION; OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE.
