A FINANCE BILL

TO APPROPRIATE A MAXIMUM OF TWO THOUSAND FIVE HUNDRED (\$2,500) DOLLARS TO UP 'TIL DAWN FROM THE SENATE CONTINGENCY ACCOUNT TO HELP DEFRAY COSTS ASSOCIATED WITH AN AWARENESS EVENT

- PARAGRAPH 1:** WHEREAS, UP 'TIL DAWN IS THE COLLEGIATE INITIATIVE OF ST. JUDE CHILDREN'S RESEARCH HOSPITAL, LOCATED IN MEMPHIS, TENNESSEE; IT IS THEIR JOB TO SPREAD AWARENESS ABOUT ST. JUDE, ENGAGE AND MOBILIZE THEIR FELLOW STUDENTS AND THE COMMUNITY AND RAISE MONEY FOR THE HOSPITAL, AND
- PARAGRAPH 2:** WHEREAS, UP 'TIL DAWN WILL HOST "BE A LIFESAVER FOR ST. JUDE," AN AWARENESS EVENT HELD AT SERRANOS; FOR WHICH FUNDS HAVE BEEN SECURED FOR LIVE MUSIC AND FOOD, AND A CANCER SURVIVOR AND THEIR FAMILY WILL BE PRESENT TO DISCUSS THEIR STRUGGLE, AND
- PARAGRAPH 3:** WHEREAS, IN ORDER TO FULLY FUND THE EVENT, UP 'TIL DAWN REQUIRES A TOTAL OF \$2,500; \$1,500 FOR THE BAND – AUTOPILOTS, \$500 FOR PROMOTIONAL MATERIAL AND \$500 FOR FOOD, AND
- PARAGRAPH 4:** WHEREAS, RAISING AWARENESS FOR DETRIMENTAL EFFECTS OF CHILDHOOD CANCER IS A CAUSE ALL LSU STUDENTS CAN RALLY BEHIND, AND THE WORK OF UP 'TIL DAWN HAS RAISED MORE THAN \$100,000 IN THE PAST;
- PARAGRAPH 5:** THEREFORE, BE IT ENACTED BY THE STUDENT SENATE OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT A MAXIMUM OF TWO THOUSAND FIVE HUNDRED (\$2,500) DOLLARS BE ALLOCATED FROM THE SENATE CONTINGENCY ACCOUNT TO DEFRAY EXPENSES ASSOCIATED WITH UP 'TIL DAWN'S "BE A LIFESAVER FOR ST. JUDE."
- PARAGRAPH 6:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
