## A RESOLUTION

TO CLARIFY AND FURTHER URGE AND REQUEST THE IMPLEMENTATION OF THE MERGING OF THE PSIF AND ORF FUNDING COMMITTEES

- PARAGRAPH 1:** WHEREAS, THE STUDENT SENATE HAS PREVIOUSLY DEBATED AND ENROLLED SGR No. 4, WHICH URGED AND REQUESTED THE MERGING OF THE PSIF AND ORF FUNDING COMMITTEES;
- PARAGRAPH 2:** WHEREAS, THERE HAVE BEEN NEW DISCUSSIONS AND IDEAS THAT NEED TO BE ADDRESSED, DEBATED AND CLARIFIED; AND
- PARAGRAPH 3:** WHEREAS, THE PSIF ACCOUNT HAS SIX (6) SUBORDINATE ACCOUNTS THAT COMPRISE THE TOTAL AMOUNT OF THE FUND; AND
- PARAGRAPH 4:** WHEREAS, MERGING ONLY THE UNDERGRADUATE ORF WITH PSIF DOES NOT SOLVE THE PROBLEM OF MISCOMMUNICATION FOR GRADUATE STUDENTS AND VETERINARY STUDENTS; AND
- PARAGRAPH 5:** WHEREAS, THE SPRING CONCERT FEE SHOULD REMAIN A SEPARATE FEE TO ENSURE FUNDING FOR GROOVIN' ON THE GROUNDS;
- PARAGRAPH 7:** THEREFORE BE IT RESOLVED THAT THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE URGES AND REQUESTS THAT THE CURRENT PSIF ACCOUNTS BE MERGED INTO ONE (1) ACCOUNT WITH THE EXCEPTION OF THE SPRING CONCERT FEE, AND THAT PSIF, UNDERGRADUATE, GRADUATE AND VETERINARY SCIENCE ORF BE MERGED INTO THE STUDENT ORGANIZATION SUPPORT FUND (SOSF);
- PARAGRAPH 9:** BE IT FURTHER RESOLVED THAT A SUITABLE COPY OF THIS RESOLUTION BE FORWARDED TO K.C. WHITE, DEAN OF STUDENTS; ERI
- PARAGRAPH 10:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU A&M STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
