A BILL

TO AMEND THE SENATE RULES OF ORDER

PARAGRAPH 1: WHEREAS, THE RULES OF ORDER OUTLINE THE LEGISLATIVE INSTRUMENTS AND THEIR VARIOUS FUNCTIONS; AND

PARAGRAPH 2: WHEREAS, A "BILL" IS CURRENTLY THE MEANS TO ALLOCATE FUNDING; AND

PARAGRAPH 3: WHEREAS, A FURTHER CLASSIFICATION OF "FINANCE BILLS" WOULD CLEARLY DENOTE THE ALLOCATION OF VARIOUS MONIES AND ALLEVIATE CONFUSION WHEN FINALIZING ALL ACCOUNTS; AND

PARAGRAPH 4: WHEREAS, CHAPTER 3, SECTIONS A-C OF THE SENATE RULES OF ORDER SHOULD READ:

- A. BILL: A binding statement of the Senate that calls for specific actions to be taken, to include but not be limited to:
1. ~~Appropriation of funds.~~
 2. Amendments to the ~~Constitution~~, Bylaws, Rules of Order, Election Code, ~~and~~ Rules of Court **and the College Councils' Constitution.**
 3. Impeachment.
- B. **FINANCE BILL: A binding statement of the Senate that calls for the specific action of allocating monies of the Student Government.**
- C. CONCURRENT RESOLUTION: A binding statement that calls for specific action to be taken concerning appointments or the issuance of a directive, to include but not be limited to:
1. Confirmation of Presidential Appointments.
 2. Confirmation of Legislative Appointments.
 3. Placement of items on a Student Government Election Ballot, ~~excluding~~ **including** amendments to the Constitution.
 4. Establishing permanent committees from the Senate.

PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT THE SENATE RULES OF ORDER BE THUS AMENDED.

PARAGRAPH 6: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
